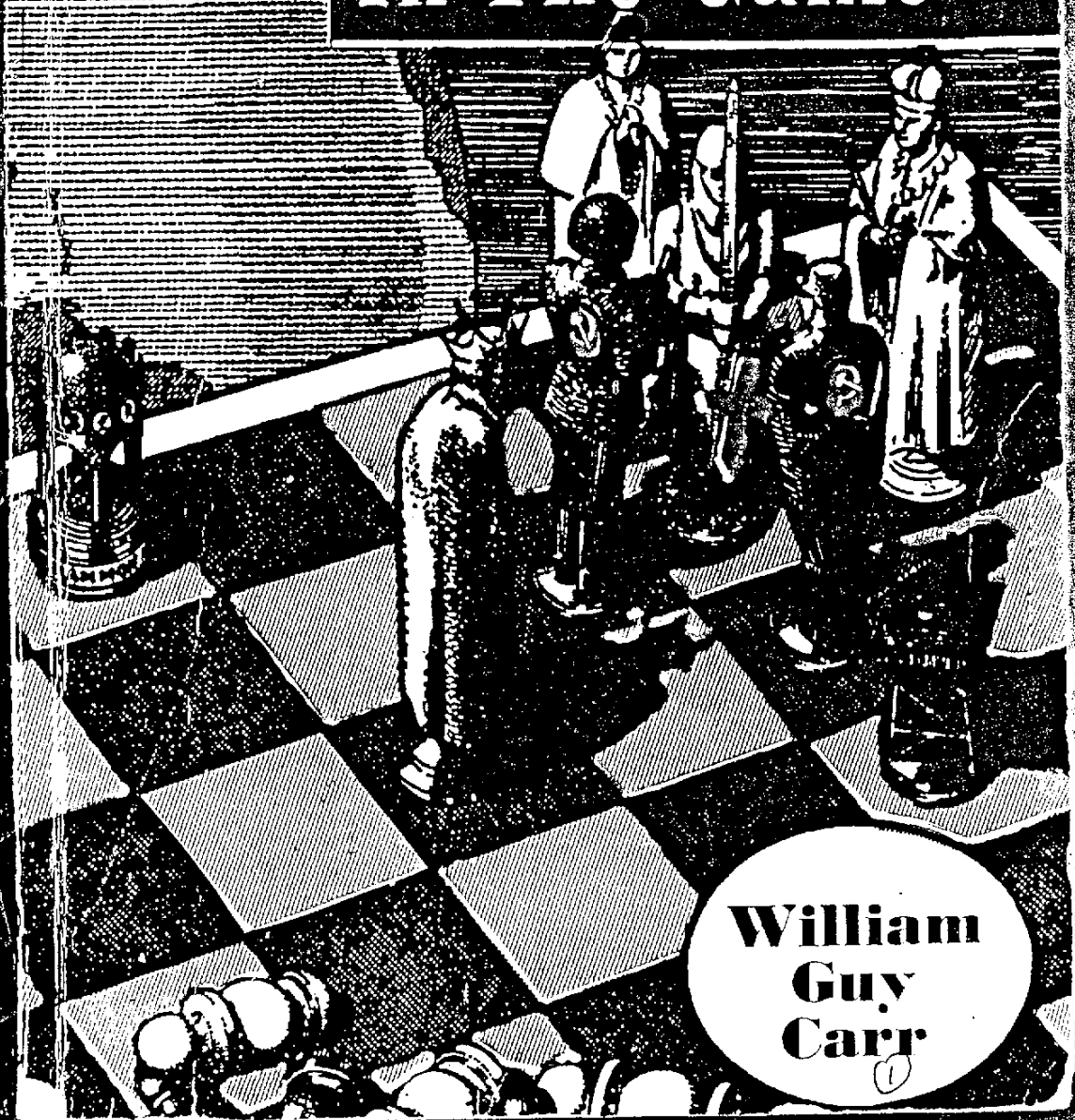

partnership. Later he returned to Frankfort where he secured control and ownership of the business which had been established by his father in 1750. The Red Shield was still proudly displayed over the door. Knowing the secret significance of the Red Shield Amschel Mayer Bauer decided to adopt it as the new family name. Red Shield in German is Roth Schild and thus *The House of Rothschild* came into being.

Amschel Mayer Bauer lived until 1812. He had five sons. All of them were specially-trained to become Captains of High Finance. Nathan, one of the sons, showed exceptional ability and, at the age of twenty-one, went to England with the definite purpose of securing control of the Bank of England. The purpose was to use this control to work in conjunction with his father and other brothers to set up, and consolidate, an International Banking Monopoly in Europe. The combined wealth of the International Banking Pool could then be used to further the secret ambitions his father had made known to all his sons. To prove his ability, Nathan Rothschild turned £20,000, with which he had been entrusted, into £60,000 in three years.

In studying the World Revolutionary Movement it is important to remember that *The Red Flag* was the symbol of the French Revolution and every revolution since. More significant still is the fact that when Lenin, financed by International Bankers, overthrew the Russian Government and established the first Totalitarian Dictatorship in 1917, the design of the flag was a Red Flag, with a Hammer and Sickle, and THE STAR OF JUDEA imposed.

nael } In 1773, when Mayer Rothschild was only thirty years of age, he invited twelve other wealthy and influential men to meet him in Frankfort. His purpose was to convince them that if they agreed to pool their resources they could then finance and control the World Revolutionary Movement and use it as their *Manual of Action* to win ultimate control of the wealth, natural resources, and man-power of the entire world.

Rothschild revealed how the English Revolution had been organized. He pointed out the mistakes and errors that had been made. The revolutionary period had been too long. The elimination of reactionaries had not been accomplished with sufficient speed and ruthlessness. The planned reign of terror, by which the subjugation of the masses was to be accomplished speedily, had not been put into effective operation. Even after all these mistakes had been made the initial purpose of the revolution had been achieved. The bankers who instigated the revolution had established control of the national economy and consolidated the national debt. By means of intrigue carried out on an international scale they had increased the national debt steadily by loaning the money to fight the wars and rebellions they had fomented since 1694.

Basing his arguments on logic and sound reasoning, Mayer Rothschild pointed out that the financial results obtained as the result of the English Revolution would be as nothing when compared to the financial rewards to be obtained by a French Revolution provided those present agreed to unity of purpose, and put into effect his carefully thought out and revised revolutionary plan. The project would be backed by all the power that could be purchased with their pooled resources. This agreement reached, Mayer Rothschild unfolded his revolutionary plan. By clever manipulation of their combined wealth it would be possible to create such adverse economic conditions that the masses would be reduced

to a state bordering on starvation by unemployment. By use of cleverly conceived propaganda it would be easy to place the blame for the adverse economic conditions on the King, his Court, the Nobles, the Church, Industrialists, and the employers of labour. Their paid propagandists would arouse feelings of hatred and revenge against the ruling classes by exposing all real and alleged cases of extravagance, licentious conduct, injustice, oppression, and persecution. They would also invent infamies to bring into disrepute others who might, if left alone, interfere with their over-all plans.*

After the general introduction to build up an enthusiastic reception for the plot he was about to unfold, Rothschild turned to a manuscript and proceeded to read a carefully prepared plan of action. The following is what I have been assured is a condensed version of the plot by which the conspirators hoped to obtain ultimate undisputed control of the wealth, natural resources, and man-power of the entire world.

1. The speaker started to unfold the plot by saying that because the majority of men were inclined to *evil* rather than to *good* the best results in governing them could be obtained by using violence and terrorism and not by academic discussions. The speaker reasoned that in the beginning human society had been subject to brutal and blind force which was afterwards changed to LAW. He argued that LAW was FORCE only in disguise. He reasoned it was logical to conclude that "*By the laws of nature right lies in force.*"

2. He next asserted that political freedom is an *idea* and not a *fact*. He stated that in order to usurp political power all that was necessary was to preach 'Liberalism' so that the electorate, for the sake of an idea, would yield some of their power and prerogatives which the plotters could then gather together into their own hands.

3. The speaker asserted that the *Power of Gold* had usurped the power of liberal rulers even then, i.e. 1773. He reminded his audience that there had been a time when FAITH had ruled but stated that once FREEDOM had been substituted for FAITH the people did not know how to use it in moderation. He argued that because of this fact it was logical to assume that they could use the idea of FREEDOM to bring about "CLASS WARS." He pointed out that it was immaterial to the success of HIS plan whether the established governments were destroyed by internal or external foes because the victor had of necessity to seek the aid of 'Capital' which "*Is entirely in our hands.*"**

4. He argued that the use of any and all means to reach their final goal was justified on the grounds that the ruler who governed by the moral code was not a skilled politician because he left himself vulnerable and in an unstable position on his throne. He said "*Those who wish to rule must have recourse to cunning and to make-believe because great national qualities, like frankness and honesty, are vices in politics.*"***

5. He asserted "*Our right lies in force. The word RIGHT is an abstract thought and proves nothing. I find a new RIGHT... to attack by the RIGHT of the strong, and to scatter to the winds all existing forces of order and regulation, to reconstruct all existing institutions,*

and to become the sovereign Lord of all those who left to us the RIGHTS to their powers by laying them down voluntarily in their 'Liberalism.'"

6. He then admonished his listeners with these words "The power of our resources must remain invisible until the very moment when it has gained such strength that no cunning or force can undermine it." He warned them that any deviation from the Line of the strategical plan he was making known to them would risk bringing to naught "THE LABOURS OF CENTURIES."

7. He next advocated the use of 'Mob Psychology' to obtain control of the masses. He reasoned that the might of the Mob is blind, senseless, and unreasoning and ever at the mercy of suggestion from any side. He stated "Only a despotic ruler can rule the Mob efficiently because without absolute despotism there can be no existence for civilization which was carried out NOT by the masses, but by their guide, who-so-ever that person might be." He warned "The moment the Mob seizes FREEDOM in its hands it quickly turns to anarchy."

8. He next advocated that the use of alcoholic liquors, drugs, moral corruption, and all forms of vice, be used systematically by their "Agenturs" * to corrupt the morals of the youth of the nations. He recommended that the special 'agenturs' should be trained as tutors, lackeys, governesses, clerks and by our women in the places of dissipation frequented by the Goyim. ** He added "In the number of these last I count also the so-called society ladies who become voluntary followers of the others in corruption and luxury. We must not stop at bribery, deceit, and treachery when they should serve towards the attainment of our end."

9. Turning to politics he claimed they had the RIGHT to seize property by any means, and without hesitation, if by doing so they secured submission, and sovereignty. He pronounced "Our STATE marching along the path of peaceful conquest has the RIGHT to replace the horrors of wars by less noticeable and more satisfactory sentences of death necessary to maintain the 'terror' which tends to produce blind submission."

10. Dealing with the use of slogans he said "In ancient times we were the first to put the words 'Liberty,' 'Equality' and 'Fraternity' into the mouths of the masses... words repeated to this day by stupid poll-parrots; words which the would-be wise men of the Goyim could make nothing of in their abstractness, and did not note the contradiction of their meaning and inter-relation." He claimed the words brought under their directions and control 'legions' "Who bore our banners with enthusiasm." He reasoned that there is no place in nature for 'Equality,' 'Liberty' or 'Fraternity.' He said "On the ruins of the natural and genealogical aristocracy of the Goyim we have set up the aristocracy of MONEY. The qualification for this aristocracy is WEALTH which is dependent upon us."

11. He next expounded his theories regarding war. In 1773 he set down a principle which the governments of Britain and the United States publicly announced as their joint policy in 1939. He said it

should be the policy of those present to foment wars but to direct the peace conferences so that neither of the combatants obtained territorial gains. He said the wars should be directed so that the nations engaged on both sides would be placed further in their debt, and in the power of 'Our' Agenturs.

12. He next dealt with administration. He told those present that they must use their wealth to have candidates chosen for public office who would be "servile and obedient to our commands, so they may readily be used as Pawns in our game by the learned and ingenious men we will appoint to operate behind the scenes of government as official advisers." He added "The men we appoint as 'Advisers' will have been bred, reared, and trained from childhood in accordance with our ideas to rule the affairs of the whole world."

13. He dealt with propaganda, and explained how their combined wealth could control all outlets of public information while they remained in the shade and clear of blame regardless of what the repercussions might be due to the publication of libels, slanders, or untruths. The speaker said: "Thanks to the Press we have got gold in our hands notwithstanding the fact that we had to gather it out of the oceans of blood and tears... But it has paid us even though we have sacrificed many of our own people. Each victim on our side is worth a thousand Goyim."

14. He next explained the necessity of having their 'Agentur' always come out into the open, and appear on the scene, when conditions had reached their lowest ebb, and the masses had been subjugated by means of want and terror. He pointed out that when it was time to restore order they should do it in such a way that the victims would believe they had been the prey of criminals and irresponsibles. He said "By executing the criminals and lunatics after they have carried out our preconceived 'reign of terror,' we can make ourselves appear as the saviours of the oppressed, and the champions of the workers." The speaker then added "We are interested in just the opposite... in the diminution, the killing out of the Goyim."

15. He next explained how industrial depressions and financial panics could be brought about and used to serve their purpose, saying "Enforced unemployment and hunger, imposed on the masses because of the power we have to create shortages of food, will create the right of Capital to rule more surely than it was given to the real aristocracy, and by the legal authority of Kings." He claimed that by having their agentur control the 'Mob,' the 'Mob' could then be used to wipe out all who dared to stand in their way.

16. The infiltration into continental Freemasonry was next discussed extensively. The speaker stated that their purpose would be to take advantage of the facilities and secrecy Freemasonry had to offer. He pointed out that they could organize their own Grand Orient Lodges within Blue Freemasonry in order to carry on their subversive activities and hide the true nature of their work under the cloak of philanthropy. He stated that all members initiated into their Grand Orient Lodges should be used for proselytizing purposes and for spreading their atheistic-materialistic ideology amongst the Goyim. He ended this phase of the discussion with the words, "When the hour strikes for our sovereign Lord of all the World to be crowned these same hands will sweep away everything that might stand in his way."

17. He next expounded the value of systematic deceptions, pointing out that their agentur should be trained in the use of high sounding phrases, and the use of popular slogans. They should make the masses the most lavish of promises. He observed *"The opposite of what has been promised can always be done afterwards... that is of no consequence."* He reasoned that by using such words as *Freedom* and *Liberty*, the Goyim could be stirred up to such a pitch of patriotic fervour that they could be made to fight even against the laws of God, and Nature. He added *"And for this reason after we obtain control the very NAME OF GOD will be erased from the 'Lexicon of life.'"**
18. He then detailed the plans for revolutionary war; the art of street fighting; and outlined the pattern for the 'Reign of Terror' which he insisted must accompany every revolutionary effort *"Because it is the most economical way to bring the population to speedy subjection."*
19. Diplomacy was next discussed. After all wars secret diplomacy must be insisted upon *"in order that our agentur, masquerading as 'political,' 'Financial,' and 'Economic' advisers, can carry out our mandates without fear of exposing who are 'The Secret Power' behind national and international affairs."* The speaker then told those present that by secret diplomacy they must obtain such control *"that the nations cannot come to even an inconsiderable private agreement without our secret agents having a hand in it."*
20. Ultimate World Government the goal. To reach this goal the speaker told them *"It will be necessary to establish huge monopolies, reservoirs of such colossal riches, that even the largest fortunes of the Goyim will depend on us to such an extent that they will go to the bottom together with the credit of their governments ON THE DAY AFTER THE GREAT POLITICAL SMASH."* The speaker then added *"You gentlemen here present who are economists just strike an estimate of the significance of this combination."*
21. Economic war. Plans to rob the Goyim of their landed properties and industries were then discussed. A combination of high taxes and unfair competition was advocated to bring about the economic ruin of the Goyim as far as their national financial interests and investments were concerned. In the international field he felt they could be encouraged to price themselves out of the markets. This could be achieved by the careful control of raw materials, organized agitation amongst the workers for shorter hours and higher pay, and by subsidizing competitors. The speaker warned his co-conspirators that they must arrange matters, and control conditions, so that *"the increased wages obtained by the workers will not benefit them in any way."*
22. Armaments. It was suggested that the building up of armaments for the purpose of making the Goyim destroy each other should be launched on such a colossal scale that in the final analysis *"there will only be the masses of the proletariat left in the world, with a few millionaires devoted to our cause... and police, and soldiers sufficient to protect our interests."*
23. The New Order. The members of the One World Government

would be appointed by the Dictator. He would pick men from amongst the scientists, the economists, the financiers, the industrialists, and from the millionaires because "in substance everything will be settled by the question of figures."

24. Importance of youth. The importance of capturing the interest of youth was emphasized with the admonition that "Our agents should infiltrate into all classes, and levels of society and government, for the purpose of fooling, bemusing, and corrupting the younger members of society by teaching them theories and principles we know to be false."

25. National and International Laws should not be changed but should be used as they are, to destroy the civilization of the Goyim "merely by twisting them into a contradiction of the interpretation which first masks the law and afterwards hides it altogether. Our ultimate aim is to substitute ARBITRATION for LAW."

The speaker then told his listeners "You may think the Goyim will rise upon us with arms, but in the WEST we have against this possibility an organization of such appalling terror that the very stoutest hearts quail... the 'Underground'... The Metropolitans... The subterranean corridors... these will be established in the capitals and cities of all countries before that danger threatens."

The use of the word 'WEST' has great significance. It makes it plain that Rothschild was addressing men who had joined the World Revolutionary Movement which was started in the Pale of Settlement in the 'EAST.' It must be remembered that before Amschel Moses Bauer settled down in Frankfort, Germany, he had followed his trade as a gold and silversmith, travelling extensively in the 'East' of Europe, where he had undoubtedly met the men his son Amschel Mayer addressed after he developed from a money-lender into a banker and established THE HOUSE OF ROTHSCHILD in the Judenstrasse where the above meeting is said to have taken place in 1773.

As far as can be ascertained the original plan of the conspiracy ended at the point where it terminated above. I am satisfied that the documents which fell into the hands of Professor S. Nilus in 1901, and which he published under the title 'The Jewish Peril' in 1905 in Russia, were an enlargement of the original plot. There appears to be no change in the first section but various additions disclose how the conspirators had used Darwinism, Marxism, and even Nietzsche-ism. More important still, the documents discovered in 1901 disclose how Zionism was to be used. It must be remembered that Zionism was only organized in 1897.

This matter is referred to later, when the intrigue leading up to the abdication of King Edward VIII is explained. The translation Mr. Victor Marsden made of *The Jewish Peril* was published by The Britons Publishing Society, London, England, under the title *The Protocols of The Learned Elders of Zion* in 1921. This book is also discussed. It appears logical to say that the discovery of the later document confirms the existence of the earlier one. Little if anything is changed, but considerable material is added probably due to the rapid development of the international conspiracy. The only point upon which there seems to be grounds for disagreement is in regard to the titles chosen by Prof. Nilus and Mr. Marsden for their books. Mr. Marsden definitely states the contents of his book are the *Protocols of the meetings of the Learned*

RENO WANTS NATIONAL 'HIT TEAMS' Could Operate — Anywhere in U.S.

What will the Justice Department do with its own SWAT team?

A bill has been introduced in Congress that would allow Attorney General Janet Reno to establish a 2,500-member "Rapid Deployment Strike Force" within the Federal Bureau of Investigation (FBI) to move into supposed local "high crime" areas to enforce both federal and local laws.

The proposal, known as the Rapid Deployment Strike Force Act, currently H.R. 97, is being sponsored by liberal Rep. Barbara Bailey Kennelly (D-Conn.) and has been referred to the House Judiciary Committee for consideration.

Under the proposed new act, the Rapid Deployment Strike Force (RDSF) would be commanded by a

deputy assistant director of the FBI and would be staffed by not only FBI agents but through the transfer of "personnel from other entities in the Department of Justice or any other federal agency."

One of the more onerous aspects of the act, the special force could include units of the U.S. military, as well as personnel of such federal agencies as the Bureau of Alcohol, Tobacco and Firearms (BATF), Drug Enforcement Agency (DEA) or any federal agency.

GUN CONTROL EFFORT

The strike force could be brought into action, according to the wording of the proposed act, to enforce federal, state and local anti-gun laws.

It says the strike force could be utilized "upon finding that the occurrence of criminal activity in a particular jurisdiction is being exacerbated by the interstate flow of drugs, guns and criminals."

The question also arises as to whether, under the act and contrary to the U.S. Constitution, members of the strike force could be forcibly housed in private homes, since it states that local officials must "demonstrate a willingness to assist in providing temporary housing facilities for members of the Rapid Deployment Force."

Under the proposed act the federal agents of the task force would be able to enforce local laws, the act requiring "Members of the Rapid Deployment Force who are deployed to a jurisdiction shall be deputized in accordance with state law so as to empower such officers to make arrests and participate in the prosecution of criminal offenses under state law."

FEMA CONNECTION

The act says "Units of the Rapid Deployment Force shall be based

WOULD GIs SHOOT AMERICANS

Would U.S. troops under UN command shoot U.S. citizens who resisted gun confiscation?

The SPOTLIGHT has obtained a copy of a survey given to members of the U.S. Marine Corps, asking, among other things, their willingness to serve in various capacities under the command of the United Nations.

Most frightening of all, however, was a question asking if they had any reservations about firing upon U.S. citizens who refuse to turn over their personal firearms as part of a gun confiscation program.

The survey was given to Marines on May 10 at the Twenty-Nine Palms Marine Corps Base, located on the southeast corner of the Mojave Desert, about 70 miles due east of San Bernardino, California, just east of Los Angeles.

Among other things, the Marine facility is the site of the Corps' Combat Center, commanded by Brig. Gen. Russell H. Sutton, and Expeditionary Air Field, which is used as a test and training center for the Marines' 1st Unmanned Aerial Vehicle Company, which utilizes unmanned aerial drones intended for long-range reconnaissance purposes.

According to a young Marine who provided a copy of the survey to The SPOTLIGHT, it was given by a Navy commander, who claimed he was "working on his masters degree" and was writing his thesis "about giving up our military's sovereignty to the United Nations secretary general."

Those taking the survey were limited to veterans of "Operation Just Cause," the U.S. invasion of Panama; "Operation Desert Storm," the war against Iraq; or "Operation Restore Hope," the supposed humanitarian mission to feed starving Somalia.

While the surveys were being passed out to the young Marines, one was able to obtain two copies from the pile of questionnaires.

Under the heading, "Combat Arms Survey," the questionnaire stated:

"This questionnaire is to gather data concerning the attitudes of combat-trained personnel with regards to nontraditional missions. All of your responses are confidential. Write your answers directly on the questionnaire form. In Part II, place an 'X' in the space provided for your response."

The series of situations posed to the servicemen is as follows:

"The U.S. runs a field training exercise. UN combat troops should be allowed to serve in U.S. combat units during these exercises under U.S. command and control."

"The United Nations runs a field training exercise. U.S. combat troops under U.S. command and control should serve in UN combat units during these exercises."

"The United Nations runs a field training exercise. U.S. combat troops should serve under UN command and control during these exercises."

"U.S. combat troops should participate in U.N. missions under United Nations command and control."

"U.S. combat troops should be commanded by UN officers and non-commissioned officers (NCOs) at battalion and company levels while performing UN missions."

"It would make no difference to me to have UN soldiers as members of my team (e.g. fire team, squad, platoon)."

"I feel the President of the United States has the authority to pass his responsibilities as Commander-in-

Chief to the UN Secretary General."

"I feel there is no conflict between my oath of office and serving as a UN soldier."

"I feel my unit's combat effectiveness would not be affected by performing humanitarian missions for the United Nations."

"I feel a designated unit of U.S. combat soldiers should be permanently assigned to the command and control of the United Nations."

"I would be willing to volunteer for assignment to a U.S. combat unit under a UN commander."

"I would like UN member countries, including the U.S., to give the UN all the soldiers necessary to maintain world peace."

"I would like to see the following code: I am a United Nations fighting person. I serve in the forces which maintain world peace and every nation's way of life. I am prepared to give my life in their defense."

"The U.S. government declares a ban on the possession, sale, transportation, and transfer of all non-supporting firearms. A thirty (30) day amnesty period is permitted for these firearms to be turned over to the local authorities. At the end of this period, a number of citizen groups refuse to turn over their firearms. Consider the following statement:

"I would fire upon U.S. citizens who refuse or resist confiscation of firearms banned by the U.S. government."

Results of the survey were not available.

The Second Amendment Takes Another Hit

-- Domestic confiscation bill, road-block gun ban passes Congress

(Wednesday, October 2) -- The Congress sent President Clinton several gun control provisions as part of the omnibus spending bill. The President signed the bill late Monday night after both house had overwhelming passed the bill (House: 370-37; Senate: 84-15).

The anti-gunners in Congress succeeded in passing several amendments in the name of defending women and children. Despite the rhetoric, the provisions will not accomplish what was claimed and blow even more holes in our Second Amendment freedoms. Here's the "cliff notes" you will need to hold your legislators accountable. What follows is a brief summary of what passed, the practical problems with those provisions, and a listing of who voted right:

Road-block Gun Ban (Sec. 657 of the Treasury-Postal portion of H.R. 3610)

- Sets up thousands of gun ban zones across roads statewide where local police or the BATF can arrest unsuspecting drivers who have a firearm in the car. Victims will face 5 years in prison.
- Also known as the Kohl amendment, this provision reenacts the School Zone Gun Ban law ruled unconstitutional by the U. S. Supreme Court last year (*U.S. v. Lopez*, 1995). The provision creates gun ban zones nearly one-half mile in diameter around every school in the country.
- Anyone without a pistol carry license driving through a zone with an unloaded firearm, that is not in a locked container or rack, faces 5 years in prison. (This would apply even to off-duty police officers, despite ineptly crafted exceptions in the Kohl language.) Many who were previously able to drive freely with guns, either in plain view or in the glove compartment, can now be victimized by anti-gun local police and/or BATF agents.¹
- And finally, just a couple of other quirks that result from the law: a) Because of the way "school" is defined in the Title 18 of the U.S. Code, the school zone gun ban could outlaw the possession of firearms by parents who home school their kids; and b) For a person who lives within 1,000 feet of a school, any hunting trip would constitute a legal labyrinth. He or she could not carry the gun to a car parked on the street unless he determined that such action was approved by school officials.

Domestic Confiscation (Sec. 658 of the Treasury-Postal portion of H.R. 3610)

- Frank Lautenberg, who has an "F-" rating from GOA, originally cosponsored the so-called domestic confiscation provision with anti-gun Senators Dianne Feinstein and Edward Kennedy as S. 1632. The largest wholesale firearms confiscation effort in decades, this provision bans thousands upon thousands of Americans from owning firearms for life, and orders their guns seized. For now this gun ban only applies to domestic dispute misdemeanors, but it sets a very bad precedent, since previously only felons have been stripped of their rights. (Note: This provision could strip many law-enforcement officers, previously convicted of domestic violence misdemeanors, of their ability to carry firearms.)
- Rep. Bob Barr introduced an NRA-supported amendment as a compromise. But even Barr's language was altered after protests from Clinton and Senate Democrats. The Barr provision -- perhaps best termed as the "Lautenberg Lite" provision -- would have reduced some of the problems with the original version, but it still extended the gun ban into the area of misdemeanors (a bad precedent).
- The Lautenberg-Barr provision which passed the Congress threatens to disarm the very women that it is supposed to help. The provision would impose a lifetime gun ban on anyone who has been convicted of "us[ing] or attempt[ing] to use . . . physical force" in a domestic situation. Of course, this "use of force" language can cover anyone (both men and women) who gets involved in a little spat between spouses, roommates, lovers, etc.
- The "use or attempted use of force" language will not only affect women who might throw a lamp at their spouse (like the First Lady), it will also endanger parents who spank their children. (Parents convicted of a domestic misdemeanor for spanking will now have to forfeit their guns or else become felons -- for being a prohibited person in possession of a firearm.) This provision federalizes a state issue and is clearly unconstitutional (under the 2nd and 10th Amendments for starters).
- What is the answer? If an act of domestic violence is serious enough to lose your civil right to own guns, then it should be a felony, which persons already were prohibited from owning firearms. If it is not serious, it should be treated as a misdemeanor -- a penalty which historically has not forced one to forfeit his or her rights.

The Washington Post (11/19/92) reported how a school teacher was arrested in class after a pedestrian reported seeing her handgun sitting in open view on the seat of her car in the parking lot. This lady had no record and was -- except for a school zone gun ban -- complying with Virginia law which allows citizens to carry a firearm in their car without a permit, as long as the gun is left in plain view.

What costs \$1 million an hour and listens in on everything you say? Insiders like to call it No Such Agency, but the National Security Agency is the largest, costliest, best-equipped and most secret spy organization in the world.

When Jacques Chirac, John Major and Helmut Kohl meet on June 26 in Lyons, France with other world leaders for the 1996 Economic Summit, they and their support staffs will be broadcasting their intentions directly to the people who advise President Clinton. Not only will the US government know more than the French, English and German heads of state regarding internal economic and political decisions, but they may actually know it earlier.

The National Security Agency spends \$1 million an hour listening to foreign (and domestic) secrets—including phone calls and faxes at the prime ministerial level.

What does NSA stand for? According to US electronic spooks: No Such Agency. Don't believe it.

America's real spies hunch over computer terminals trying to break foreign codes. Or they have their ears pressed to headphones, patiently listening to stolen conversations. They do not report to the CIA. They are among the thousands who work for the National Security Agency, the world's largest, costliest and most secret intelligence organization.

From a sprawling complex at Ft. Meade, tucked between Washington and Baltimore, NSA listens to the world. Using a vast network of satellites, along with global eavesdropping posts that stretch from Alaska to Capetown, the agency monitors everyone from drug traffickers and terrorists to businessmen and government officials—even allies.

Serbian commanders radioing their troops in Bosnia are unwittingly talking to Serbo-Croatian linguists in a glass tower at Ft. Meade, just one of more than 100 languages spoken there, everything from Icelandic to Senegalese. Through NSA's eavesdropping, American officials have tracked the ties of Russian President Boris Yeltsin with Serbian President Slobodan Milose-

vic, and those of Milosevic with Bosnian Serb leader Radovan Karadzic.

High-tech equipment aboard US reconnaissance aircraft routinely picks up Serbian radar signals and flashes them back to NSA headquarters where computers identify missile batteries, zapping the analysis back to NATO pilots. Time for the round trip? Eleven seconds.

Since the recent rash of terrorist bombings in Israel, NSA's Arabic linguists have zeroed in on the phone calls and radio communications of the radical Islamic group Hamas, which has claimed responsibility for the carnage. Intelligence reports shared with the Israelis by CIA Director John Deutch carefully disguised the data's source.

But Israel is a target too, though the fact that NSA listens to allies is a closely-held secret of this secret organization. In England, NSA maintains its largest overseas post, Menwith Hill Station, a complex of huge microwave dishes and white radomes resembling giant golf balls. Among the NSA linguists on the staff are some whose specialty is

War, from the Cuban Missile Crisis to the Vietnam War and the Gulf War. During the late 1960s and early 1970s, in a project codenamed GAMMA GUPY, American agents listened to the private radios of Politburo members as they raced along Moscow streets in their Zil limousines.

"All the equipment, all the money went to the Russian and Eastern European groups," said one former NSA Arabist. "The people in A Group, they were the stars," said another former listener, who translated Greek government cables.

But it didn't take long for this agency of skilled bureaucrats to find new airt. With President Clinton's emphasis on global economic competition, NSA has shifted many of the resources it once used for the Kremlin to the commercial communications of European and Asian nations.

When Boeing and McDonnell Douglas were locked in a fierce struggle with the European consortium Airbus for a \$6 billion contract to replace the Saudi airline fleet, NSA stepped in. Sifting through phone calls and faxes between Paris and Riyadh, NSA found a nugget: unmistakable evidence that agents for Airbus offered bribes to a high-level Saudi official.

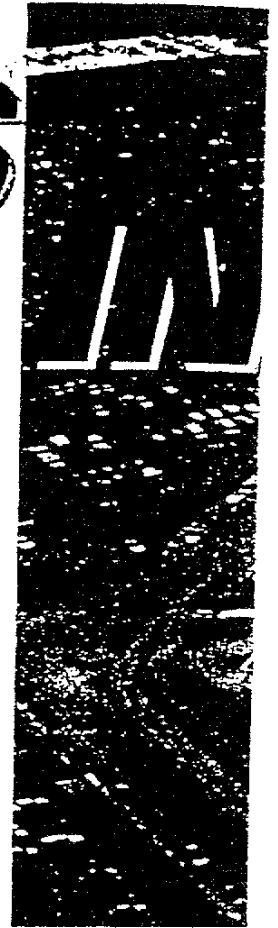
Said one top Clinton administration official: "Intelligence on bribery lets us know what we're up against. We're better prepared."

When US trade negotiators sit across the table from foreign counterparts, chances are good they have read transcripts detailing their opponents' instructions.

NSA provided just such assistance to US negotiators during tense talks with Japan last year over luxury car imports. One American trade envoy who works closely with NSA says he sometimes struggles at the negotiating table not to betray what he has learned from the eavesdroppers.

"You have to make sure there's no extra spring in your step, he says."

While NSA is charged with listening to foreigners, its dishes routinely pick up Americans' overseas calls as



well. Since 1975, when congressional investigators found the agency had files on 75,000 Americans and was eavesdropping on anti-Vietnam War protesters, NSA has been banned from deliberately targeting Americans. But the agency cannot exclude Americans' communications from its electronic net, and the law says only that Americans' names must be removed from intelligence reports, with the words "US person" substituted. Perhaps worse, when the NSA trains its agents in the highly technical art of eavesdropping, US law gives them the right to practice—on you.

NSA agents may lawfully hone their listening skills and test their equipment on the most intimate telephone calls of ordinary US citizens, as long as notes and tapes are destroyed "as soon as reasonably possible."

"We listened to all the calls in and out of Washington," says one former NSA linguist, recalling a class at the Warrenton Training Center, a CIA communications school on a Virginia hilltop. "We'd listen to senators, representatives, government agencies, housewives talking to their lovers."

Wiring the world requires lots of ingenuity, lots of manpower and lots of the taxpayers' money.

While the better known CIA spends about \$3 billion each year and employs about 15,000, NSA has 20,000 workers at its headquarters alone and tens of thousands of mostly military eavesdroppers

Since its creation in 1952 by President Harry S. Truman whose executive order establishing the agency was itself top secret, NSA's primary target has been the Soviet Union. When the communist monolith collapsed, NSA's priorities shifted. The agency played a role in virtually every major event of the Cold

deployed around the world. The price tag? About \$2.5 billion, along with another \$4 billion to \$5 billion to launch and maintain its fleet of satellites and pay overseas salaries for uniformed personnel. NSA's rivals at the CIA gripe that what they pay to recruit informants is pocket change compared with what NSA spends on technology.

When a Titan IV rocket exploded shortly after its launch in California in August 1993, the blast destroyed its secret payload: three eavesdropping satellites worth \$275 million apiece, officials said. The damage equaled the National Park Service's annual budget. Such satellites unfurl ultralight foil dish antennas the size of a football field. Orbiting above target countries, they catch the microwaves signals of telephone calls and faxes as they radiate from relay towers.

From ground stations in Sugar Grove, W.Va., and Yakima, Wash., in England, Germany, Japan, Australia and elsewhere, NSA beams its signals to a communications satellite in orbit. The commercial communications satellites that carry the bulk of the world's phone, fax, computer and other traffic. In other words, operating in Germany, England, France and other countries, NSA eavesdrops on the host countries' leadership, government, business and on its citizens.

"Every time a communications satellite is launched, NSA puts up a satellite dish to keep track of it," says John

Pike, an intelligence expert at the Federation of American Scientists in Washington. "That dish sits there and says, 'One copy of everything, please.'" When foreign officials visit the United States, NSA bugs their hotel rooms. Working with designated telephone company employees, NSA delivers a list of targeted numbers and appropriate legal papers. Phone company technicians push a few buttons to make the connection.

Sometimes the eavesdroppers can't operate at such a safe distance. NSA technicians operating under wiretapping code names such as "Musketeeer" and "Broadside" sometimes take their listening tools close to the source.

By bouncing a laser off an office window, NSA listeners can pick up the conversation inside from the subtle vibration of the glass. Technicians put tiny transmitters into vas-

crete and drywall of every office with undetectable fiber-optic listening devices. In August, 1990, when the Chinese moved into their \$13 million embassy, the harvest began.

As the diplomats set about their work, their conversations and computer keystrokes were flashed by satellite to the other side of the globe: candid talk about relations with Taiwan, secret cables with details of Beijing's trade deals, reports on the latest military hardware.

While only some foreign embassies are wired by NSA, nearly all US embassies are part of the agency's vast collection network.

The Special Collection Service, an elite eavesdropping unit handpicked from the ranks of NSA and CIA, handles the delicate task of listening from windowless rooms inside embassies, consulates and other US facilities abroad. So secret that most employees

NSA has often been derided in the spy world as a haven for desk-bound technicians who rarely venture far from their ranch homes in the subdivisions around Fort Meade. But there are hundreds of people working for SCS whose lives mirror the characters in spy novels. When they leave the Maryland field site, they have cover stories, foreign currency and business cards complete with the phone number of a fictitious boss who will vouch for them. And they are often headed to some of the most volatile countries in the world.

NSA is the nation's largest employer of mathematicians and wields the greatest concentration of computing power on earth. That kind of number-

codes. It has dispatched FBI agents on break-in missions to snatch code books from foreign facilities in the United States. CIA agents recruit foreign communications clerks and buy their code secrets.

NSA's boldest coup in codebreaking took place in an unlikely location: Zug, Switzerland, the home of a manufacturer of encryption equipment called Crypto AG. For years, NSA secretly rigged Crypto AG machines so that US eavesdroppers could easily break their codes, according to former employees and company documents.

Why Crypto? Wary of comparatives in NATO countries, the suspicious governments of such prime US targets as Iran, Iraq, Libya and Yugoslavia bought equipment from the Swiss firm. Using messages created on the Swiss machines, these countries and others may have been sending an easily unscrambled copy directly to Fort Meade.

Considering the breadth and depth of NSA, it is little wonder that delegations to this month's Group of 7-1 (US, Canada, Britain, France, Germany, Italy, Japan plus Russia) are under orders to be careful about what they say, whether in conversation, via fax, or by computer. Paranoid? NSA listeners can pick up the electronic transmissions of computer keyboards, effectively learning the contents of a government report before it is printed for the leader of the same government to read.

The NSA wields the world's greatest concentration of computing power; it can crack the most daunting of codes

es, ashtrays and other everyday objects to be smuggled into a targeted building.

"Everything down to the toothpick in your glass, NSA could do it," recalls a retired senator.

When the Chinese built a new embassy in Canberra, Australia, NSA outdid itself. Thirty US agents had worked for months to lace the con-

Gorbachev, Bush Lead the Charge

Just as San Francisco was the birthplace of the United Nations, now the "city by the bay" will host a meeting to establish ground rules for governing a united world.

Former Soviet President Mikhail Gorbachev has been named the "convening chair" and host of a world forum on the "first global civilization" planned for San Francisco from September 27 to October 1.

Elitists at the conference are scheduled to consider how the so-called "new world order" will be governed.

The last dictator of the fallen Soviet Union, Gorbachev has ensconced his Gorbachev Foundation USA in the former Coast Guard commandant's residence at the closed U.S. military base, the Presidio, in San Francisco.

The SPOTLIGHT has learned former President George Bush and ex-British Prime Minister Margaret Thatcher have agreed, among others, to serve as co-chairs of the forum slated for San Francisco's Fairmont Hotel.

Others to co-chair the meeting on

the so-called new world order include: Ted Turner, U.S. television mogul; George Shultz, a former secretary of state; Askar Akaev, president of the Soviet break-away republic of Kyrgyzstan; Tansu Ciller, prime minister of Turkey; Vaclav Havel, prime minister of the Czech Republic; Bilderberger Ruud Lubbers, ex-prime minister of the Netherlands; Rigoberta Menchu, Guatemala, like Gorbachev a recipient of the Nobel peace prize; Yasuhiro Nakasone, former prime minister of Japan; Julius Nyerere, ex-president of Tanzania and Desmond Tutu, Episcopal archbishop of South Africa.

In explaining the purpose of the forum, former U.S. Sen. Alan Cranston (D-Calif.), chairman of the Gorbachev Foundation USA, lamented that hopes for a new world order following the cold war have dimmed.

"There appears to be a great cynicism everywhere with government," Cranston said. "And there is a yearning for new directions."

About 8,000 business leaders from 75 countries have been invited to attend as paying participants at a cost of \$8,000 each, which will bring the tax-exempt Gorbachev Foundation USA a total of \$64 million, if all attend.

Other invited guests include Vice President Al Gore, President Nelson Mandela of South Africa, ABC newsman Ted Koppel, novelist Isabel Allende, Zbigniew Brzezinski, national security adviser in the Carter administration, Jessica Tuchman

Joint Military Operations Confirmed

This populist newspaper's exclusive reports about foreign troops and combat equipment maneuvering on U.S. soil have now been confirmed by an official statement. But most Americans never heard it. and psychological warfare techniques are involved in the bi-national deployments, Gen. Grachev added.

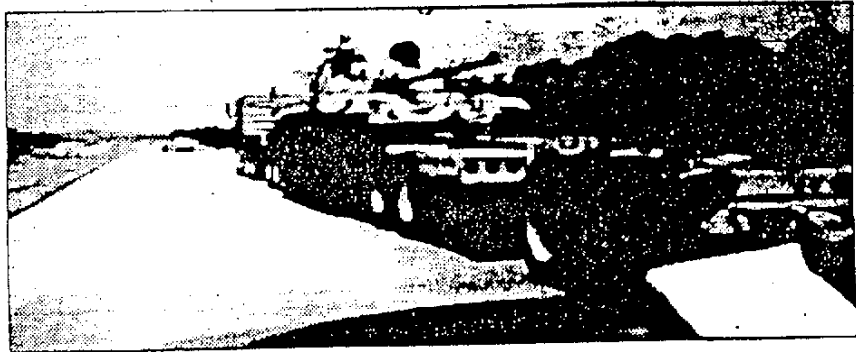
CONFIRMATION CALL

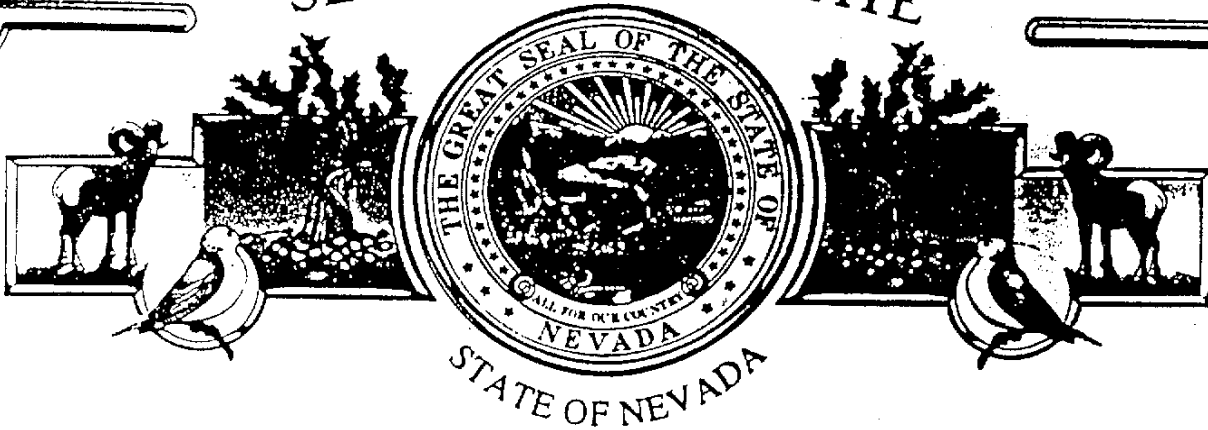

Homosexual prostitution probe Ensnnares officials of Bush, Reagan

'Call boys' took midnight tour of White House

A homosexual prostitution ring is under investigation by federal and District authorities and includes among its clients key officials of the Reagan and Bush administrations, military officers, congressional aides and U.S. and foreign businessmen with close social ties to Washington's political elite, documents obtained by The Washington Times reveal.

One of the ring's high-profile clients was so well-connected in fact, that he could arrange a middle-of-the-night tour of the White House for his friends on Sunday, July 2, of last year. Among the six persons on the extraordinary 1 1/2-hour were two male prostitutes.

Federal authorities, including the Secret Service, are investigating criminal aspects of the ring and have told male prostitutes and their homosexual clients that a grand jury will deliberate over the evidence throughout the summer. The Times learned.

Reporters for this newspaper examined hundreds of credit-card and personal cards and male prostitutes, drawn on both corporate and personal cards and male prostitutes by the homosexual ring. Many of the vouchers were run through a so-called "handbook" account of the Chambers-Pulverer Home by a son of the owner, without the company's knowledge.

Among the client names contained in the vouchers — and identified by prosecutors and secret operations — are government officials, locally based U.S. military officers,

businessmen, lawyers, bankers, congressional aides and other prominent names of those found to be in sensitive government posts or positions of influence. There is no intention of publishing names or facts about the operation merely for "utilitarian"

said Wesley Proden, managing editor of the Times.

The office of U.S. Attorney Jay B. Stephens, former deputy White House counsel to President Reagan, is coordinating federal aspects of the inquiry but refused to discuss the investigation or grand jury action.

Several former White House colleagues of Mr. Stephens are listed among clients of the homosexual prostitution ring, according to the credit-card records, and those persons have confirmed that the charges were theirs.

Mr. Stephens' office, after first saying it would cooperate with the Times' inquiry, withdrew the offer late yesterday and also declined to say whether Mr. Stephens would recuse himself from the case because of possible conflicts of interest.

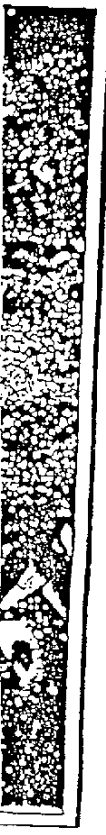
All but one highly placed Bush administration official and a wealthy businessman who procured homosexual prostitutes from the secret services operated by the ring are several sources said.

Among clients who charged homosexual prostitute services on their credit cards over the past 18 months are Charles K. Dutschler, former associate director of presidential personnel in the Reagan administration, and Paul S. Blalock, Labor Secretary Elizabeth Dole's political personal liaison to the White House.

In the 1970s, Mr. Dutschler was a congressional aide to former Rep. Robert Farnum, Maryland Republican, who resigned from the House after he admitted having engaged in sexual liaisons with teenage male

Power broker served drugs, sex at parties bugged for blackmail

Craig J. Spence, an enigmatic figure who threw glittery parties for key officials of the Reagan and Bush administrations, media stars and top military officers, bugged the gatherings to compromise guests, provided cocaine, blackmailed some associates and spent up to \$20,000 a month on male prostitutes, according to friends, acquaintances and records.

The 48-year-old D.C. power broker has been linked to a homosexual prostitution ring currently under investigation by the U.S. Attorney's Office. Its clients included several top government and business officials from Washington and abroad.

Among the clients identified in hundreds of credit-card vouchers obtained by The Washington Times — and identified by male prostitutes and escort operators — are government officials, locally based U.S. military officers, businessmen, lawyers, bankers, congressional aides, media representatives and other professionals.

Mr. Spence's influence appeared unlimited, aptly demonstrated by his ability to arrange midnight tours of the White House, according to three persons who said they took part in those tours.

"It was a show-the-flag time for Craig Spence," said one person who went on a July 3, 1988, tour that included two male prostitutes. "He just wanted everyone to know just how damned powerful he was," said the person. "And when we were strolling through the White House at 1 o'clock in the morning, we were believers."

One man who was on the tour but asked not to be named for fear it would damage his business said it was cleared by a uniformed Secret Service guard whom the man had seen attending Mr. Spence's parties as a bodyguard.

RNC calls scandal a 'tragic situation'

Republican and conservative political leaders reacted cautiously yesterday to a report in The Washington Times that key Reagan and Bush administration officials are ensnared in a federal probe of homosexual prostitution.

"There's no reason for cleaning anybody out [of office because they used homosexual prostitutes]," said Leslie Goodman, a spokeswoman for

Republican National Committee Chairman Lee Atwater.

"It's a personal situation. It's a tragic situation if people have to resort to prostitutes," the GOP spokeswoman said. "But there's no standard for people in the federal government that's different than for the average Joe on the street."

However, a top Labor Department adviser to Secretary Elizabeth Dole resigned yesterday after acknowledging to The Times that he

tion, and Craig Spence, a "conservative" Washington socialite, political fixer, and international trade consultant, who arranged a nocturnal tour of the White House for a group that included two male prostitutes. One of the chief operators of "Professional Services," Henry Vinson, used to work for the clerk of the House of Representatives.

Both Vinson and Balach told the Times that the investigation would be restricted because "big names" were involved. Vinson said he believes that highly placed federal official, whom he would not name, is working to derail the investigation. Sources say that either a top Justice Department or White House official is working full time to ensure a cover-up of the ongoing investigation.

The need for "damage control" is necessitated by a serious concern that the Soviet KGB may have used the ring to entrap people in sensitive government positions. In 1982, the Italian media carried stories reporting that then-Soviet chief Yuri Andropov had a blackmail file on known homosexuals in top government positions, including former Secretary of State Henry Kissinger.

Lt. Gen. Daniel Graham, former head of the Defense Intelligence Agency, told the Times that for the past eight years, military and civilian intelligence authorities have been concerned that a "nest of homosexuals" at top levels of the Reagan administration may have been penetrated by Soviet-backed espionage agents posing as male prostitutes.

"We have known for many, many years that there is a department of the KGB whose job it is to prey on sexual deviants," he said. The Justice Department has denied that it is looking into the Soviet angle.

The operators of the ring have acknowledged making videotapes, audiotapes and still photographs of sex acts performed by clients and the "call boys." Several of the operation's clients have admitted being blackmailed.

Filmed Orgies

One of the powerbrokers to use the prostitution ring was Craig J. Spence. He regularly threw orgies for major figures in the Reagan and Bush administration, which were covertly filmed and bugged, the Washington Times reported today. Spence has been named as one of the key figures

in the call-boy network used by these officials, and spent \$20,000 a month on male prostitutes. Persons who regularly attended Spence's parties, according to the Times, included former CIA director William Casey; journalists Eric Sevareid, Ted Koppel, and William Safire; the late Attorney General John Mitchell; conservative activist Phyllis Schlafly; U.S. Ambassador to Beijing James Lilly; and General Alfred Gray, the commandant of the Marine Corps. The Times also reports that its editor, Arnaud de Borchgrave, had attended one dinner reception at Spence's home honoring Lilly. The former U.S. Attorney in the District of Columbia, Joseph di Genova, also frequently attended the parties. All the parties were covertly filmed through two-way mirrors, reported the Times.

Executive Intelligence Review was the first publication to alert the public of the national security threat posed by having a "nest of homosexuals" in the Reagan-Bush administration. The Feb. 27, 1987 issue of EIR reported, "High-level Intelligence sources have revealed to EIR that the 'gay' Republican Party apparatus is under scrutiny in the Iran/Contra scandal investigations. These sources believe that the 'gay' network within the GOP ... may have ... compromised the National Security Council (NSC) through Lt. Col. Oliver North's Project Democracy." The EIR article then reported that North's righthand man Carl "Spitz" Channell, and his extended network of homosexual Republican fundraisers, were the same people who raised money for the Contras while attacking the LaRouche-inspired anti-AIDS campaign.

Authorities involved in the investigation are also looking at the possibility that Satanism may be a part of the scandal. The ring used a local funeral parlor as a cover—as well as illegal interstate prostitution, abduction and use of minors for sexual perversion, extortion, larceny, and related illicit drug trafficking. The abuse of children raises the possibility that the ring also indulged in Satanism.

The White House has refused to comment and Republican National Committee spokesman Leslie Goodman said, "It's a personal situation if people have to resort to prostitutes. But there's no standard for people in the federal government that's different than for the average Joe on the street."

NEBRASKA COVER-UP

On November 4, 1988, the Franklin Credit Union, Omaha Nebraska was closed, as the result of a raid by the FBI and the IRS. It was initially opened in a minority neighborhood to provide minorities with a source for loans and other banking opportunities. Larry King, a black man, was the president. He was a rapidly rising "star" in the Republican party, having previously, sung the National Anthem at the Republican National Convention in Dallas, Texas, and New Orleans, Louisiana. Forty million dollars was missing, \$38 million of which was subsequently located, with \$2 million still missing. King's salary was \$17,000.00 per year.

On November 18, 1988, the Nebraska state legislature passed a resolution to investigate the Franklin Credit Union. As a result of this investigation, approximately 80 youngsters came forward and made allegations concerning sexual abuse as well as cult activity, including the human sacrifice of small children. Some of the most prominent community leaders, including the former publisher of the **Omaha World Herald**, Harold Andersen; the then chief of police, Robert Wadman; the society editor of the **Omaha World Herald**, Peter Citron; a former State Senator; multi-million dollar heir to Brandeis Department, Eugene Mahoney, were among those identified as perpetrators. Some of these individuals, were among those identified as involved in cult activities and human sacrifices.

Of the number of children making the allegations, only four agreed to give statements. Two of the four later recanted, but the remaining two refused to recant and held steadfast concerning their allegations. Criminal charges were filed against the two who refused to recant. One of the two, Alisha Owens, was convicted of having committed perjury before a grand jury and served two years in prison in solitary confinement. This is the longest any woman has been held in solitary confinement in the history of the State of Nebraska. (The case is under appeal. If lost, she could face up to 25 years in prison.) Charges against the other witness, Paul Bonacci, were dropped, as he had been convicted of child molestation and it apparently was felt that he had already been discredited. Subsequent investigation established that children were taken from Boys Town and a private girls' school, driven to Sioux City, Iowa, placed in private jets and flown to Washington, D.C., and other communities for sex orgies with U.S. congressmen, U.S. senators, at least one top official in the White House and other public officials. Information was also developed that the children were used as decoys for an around-the-world drug operation. They were also used in an organized child kidnapping sex slave ring in which children were kidnapped, and used in porno films and snuff films. Some were auctioned off near an air strip close to Las Vegas, Nevada and Toronto, Canada. A 10 to 13 year old blue-eyed blonde sells for \$50,000 or more. Some of these children were placed in airplanes that carried no markings and they have not been seen since. Many were sold to foreigners. Some of the children have stated that at least one of the airplanes belonged to the U.S. Drug Enforcement Agency (DEA).

Some of the sex orgy parties were held in a condominium in Washington D.C., that was rented by Larry King for \$5,000 per month.

Paul Bonacci, who has drawn a diagram of the living quarter inside the White House, said he met Craig Spence and Larry King in the White House on one occasion. It is a known fact that Spence was running a male call-boy operation in the White House, (Washington Times, June 26, 1989.) Spence supposedly committed "suicide" after this information became public. He reportedly was a CIA agent who specialized in Blackmailing politicians and foreign dignitaries. Information has been received that at least one FBI agent conspired with Spence.

Paul Bonacci told how he flew to Los Angeles on one occasion, met a man and a woman he had never seen before and the three, using five different names and passports, flew drugs throughout the world. He estimates he has made more than 100 such drug runs.

Fifteen people have died mysteriously, including the senate ~~committee~~ appointed investigator, Gary Caradori, and his young son Andrew. Caradori's plane exploded in mid-air shortly after leaving Chicago, Illinois, for Lincoln, Nebraska on July 11, 1990. The day before, he called the chairman of the senate investigating committee Lauren Schmit and told him he had irrefutable evidence that the children were telling the truth.

The investigation of the plane explosion was conducted by the Federal Government at a military installation. No testing was done for phosphates to rule out an explosion. The toxicology tests of the bodies were conducted at a military base laboratory rather than at the civil National Transportation and Safety Board laboratory. The military lab reported an inability to test for certain chemicals. Neither Caradori's briefcase nor the rear seat of the airplane have been found. We have received information from an informant that a phosphorus bomb was used to destroy the airplane. It may have been placed under the rear seat which would account for failure to locate it. If located the seat may provide forensic proof whether or not a phosphorus bomb was used.

At the time of the plane crash, former Omaha Chief of Police, Bob Wadman, who was identified by the children, was chief of police in Aurora, Illinois, which is 30 miles from the crash site. Wadman is believed to have visited the crash site immediately after the crash.

It is a violation of the Federal Delimitation's Agreement for civilian matters to be investigated by the military.

Alisha Owen's brother, Aaron Owen, died November 9, 1990 which was less than six months after Owens refused to recant her allegations and prior to her perjury trial. Aaron reportedly hanged himself in a correction center cell. Alisha believes he was murdered in an attempt to keep her from telling the truth.

Troy Bonner, who initially made allegations and then recanted contacted Senator Schmit, chairman of the investigation committee, after the Caradori plane crash. Remorseful over Caradori's death, Bonner admitted he lied before the grand jury and was fearful for his life should he tell the truth in the upcoming trial of Owen. Prior to the trial and after this meeting with Senator Schmit and 8 other legislators, Bonner's brother, Shaun Bonner, was killed reportedly while playing "Russian roulette" at Offutt Air Base near Omaha. This death occurred two months after the death of Aaron Owen. Bonner advised his brother hated guns and he never knew him to play Russian roulette. In affidavits submitted to the U.S. District Court, Bonner states he believes his brother was murdered as a personal death threat to him (Troy) should he decide he would tell the truth at the Owen's trial.

Peter Citron, past society editor of the **Omaha World Herald**, who was identified by the youngsters as a perpetrator, was arrested by the Omaha police for sexual assault of two children on February 23, 1990. At the time of the arrest, the police confiscated more than 90 videotapes which reportedly contain sexual acts of some of the youngsters with perpetrators.

Mr. John DeCamp, a Lincoln, Nebraska, attorney who is representing some of the youngsters, pro bono, in a civil suit, claims these videotapes are the "smoking gun" in this case. Initially, it was alleged that there were no tapes. When it was documented that the tapes exist, it was denied that the perpetrators identified by the children were on the tapes. The accused later argued in court that the tapes should not be made public, as it would destroy the reputation of "respectable" and "reputable" citizens.

Thus far, Mr. DeCamp has been blocked by the courts in exposing these tapes as the court has said that the tapes will not be made public. A gag order has been issued to all parties concerning the contents of the videos. Mr. DeCamp can only review them without taking notes. At the conclusion of the case, the video tapes will be destroyed per a court order.

Within the past year, Yorkshire T.V. in England produced a documentary on this case entitled **Conspiracy of Silence**. It was sold to the Discovery Channel and scheduled to air on national T.V. on May 3, 1994. The Discovery Channel is a division of Cox Television, Atlanta, Georgia. The major stockholders of Cox T.V. have been financial supporters of the Republican Party and have direct ties to former President George Bush. This documentary among other things, states that Larry King's Washington D.C. home on embassy row was said by child victim witnesses to have been used for the child/adult sex orgies involving important Washington D.C. insiders, including a very high level White House official. The documentary, scheduled for airing May 3, 1994, was never shown, even though it was listed in the **T.V. Guide**.

The latest development on the case involved a \$9 million settlement of a civil suit with the National Credit Union Association. The National Credit Union Association, which represents the insurance interest in the case, sued the law firm that represented the

Franklin Credit Union and the First Tier Bank in Omaha, claiming that they were aware of the various illegal activities on the part of those involved in the Franklin Credit Union case. Rather than go to trial, the law firm paid, \$6 million and First Tier Bank paid \$3 million. The lawsuit documents that Franklin Credit Union funds were used to pay for campaign films for former President Bush, to rent the condominium in Washington, D.C. and to pay for private jets to fly to Washington, D.C.

The law firm advised, it avoided a trial because it would have been too strenuous to their staff. In addition to the allegations of human satanic cult sacrifices, drugs, pedophilia, pornography and snuff films, there is documentation that some of the most prominent people in the country, including individuals actively involved in the U.S. civilian and military intelligence communities, are participants in these activities and involved in this network. Some of the youngsters have talked about witnessing ceremonies in which the participants wore black robes with hoods, sacrificed children and drank human blood and urine. (sentantic traits in rituals.) There are numerous references by the children to activity being conducted on U.S. government and military installations.

American Information Company (AIC) of Omaha Nebraska provides 32 voting districts in the U.S. and others internationally with scanning computerized election services. They are a private company that can be hired to count the vote in public elections. The Omaha World Herald owns 45% of its stocks.

Two days before the June 1994 Nebraska & Republican primary Mr. John DeCamp one of four candidates running for governor led the private primary polls with 33% of the vote. After the election and the count by AIC he placed third with less than 14% of the vote.

Information has been provided by the children that there is an organized pedophile ring that transports children for sex orgies from Omaha, Nebraska to Des Moines, Iowa, Minneapolis, Minnesota, Milwaukee and Madison, Wisconsin and return. The youngsters have made numerous references to an organized child kidnapping ring that is being ignored by law enforcement officials. Mr. Ted L. Gunderson, the former Senior Special Agent in Charge of the FBI Los Angeles Division has informed the FBI by registered mail of this in an attempt to pressure them into conducting an investigation. He has been told that the FBI is not interested in these matters.

The July 1982 **Readers Digest**, states that 100,000 children disappear every year and are never heard from again. The U.S. Department of Justice and the FBI can furnish the number of automobiles that are stolen each year, and provide other criminal statistics. They can furnish how many wives, husbands, sons, daughters, fathers, brothers, mothers and sisters are murdered by each family members (**Time Magazine 10/25/93**). Government officials can provide the first names of missing children nationwide since 1989 (**Las Vegas Review Journal E 16 7/24/94**), yet they do not collect data on the number of children who disappear each year.

In spite of the fact that some of the children in the Franklin case can assist law enforcement in these matters, the police and the FBI claim the children have no creditability. Does this mean that the FBI now has a new policy not to talk to convicts or ex-convicts because the convicts have no creditability? Is the FBI not talking to the youngsters because of the many prominent people involved? One wonders how well organized this network is and how high its tentacles reach into the Government.

Subsequently, this office received a telephone call from the Washington, D.C. Metropolitan Police Department inquiring about the men and children. This office put the MPD and the TPD in contact with each other.

On Thursday, February 5, 1987, this office was contacted via telephone, by sergeant, JoAnn VanMETER of the Tallahassee Police Department, Juvenile Division. Sgt. VanMETER requested assistance in identifying two adult males and six minor children ages 7 years to 2 years.

The adult males were tentatively identified by TPD as Michael HOULIHAN and Douglas AMMERMAN, both of Washington, D.C., who were arrested the previous day on charges of child abuse.

The police had received an anonymous telephone call relative two well-dressed white men wearing suits and ties in Myers Park, (Tallahassee), apparently watching six dirty and unkempt children in the playground area. HOULIHAN and AMMERMAN were near a 1980 Blue Dodge van bearing Virginia license number XHW-557, the inside of which was later described as foul-smelling filled with maps, books, letters, with a mattress situated to the rear of the van which appeared as if it were used as a bed, and the overall appearance of the van gave the impression that all eight persons were living in it.

The children were covered with insect bites, were very dirty, most of the children were not wearing underwear and all the children had not been bathed in many days.

The men were arrested and charged with multiple counts of child abuse and lodged in the Leon County Jail. Once in custody the men were somewhat evasive in their answers to the police regarding the children and stated only that they both were the children's teachers and that all were enroute to Mexico to establish a school for brilliant children.

The children tentatively were identified as Mary HOULIHAN, white female, age 7; Max LIVINGSTON, white male, age 6; Benjamin FRANKLIN, white male, age 4; HoneyBee EVANS, white female, age 3; B.B., white male, age 2; and John Paul HOULIHAN, white male, age 2. The children initially indicated that they lived in tents in a commune in the Washington, D.C., area and were going to Mexico to go to a school for smart kids.

This office contacted the Office of the RAC/DC and spoke with SS/A, Bob Harrold. This agent requested telephone numbers and names of police persons in area departments that might be aware of said activities described by the children and to follow-up on the leads which were the Virginia license number and a check on the men's names with local law enforcement.

A short time later this office was contacted by Detective, Jim Bradley of the Washington, D.C., Metropolitan Police Department. Bradley indicated that the case here in Tallahassee appeared to be strongly related to a case he was currently working in the Washington, D.C. area.

He stated that the actions of the two men in custody in Tallahassee relative the children just might give his case enough probable cause for search warrants to search premises occupied by a cult group called the FINDERS.

This agent directed Bradley to telephone TPD and discuss with police directly any activities forthcoming relative the instant case.

At this time it was determined that there was no Customs violations found to exist and therefore, this case is being closed pending receipt of additional information.

On Thursday, 2/5/87, the duty agent, SS/A Bob Harrold, received a call from SS/A Walter Krietlow, USCS, Tallahassee, Florida. SS/A Krietlow was seeking assistance in contacting an appropriate local police agency to coordinate a child abuse investigation in with the Tallahassee Police Department. SS/A Krietlow further requested assistance in checking some names, addresses and a vehicle through the Customs Child Pornography Unit data base, and stated there was some suspicion of the subjects being involved in supplying children for the production of child pornography. Further, he was informed by the Tallahassee Police Department that the children may have been enroute to Mexico from the Washington, D.C. area. The possibility of Customs interest in the investigation due to possible violations of the Child Protection Act of 1984, and the alleged nexus with the U.S./Mexican Border were discussed and agreed upon. SS/A Krietlow related the following background information. SS/A Krietlow was contacted by the Tallahassee Police Department for assistance in identifying six children and two adults taken into custody in the Tallahassee area. U.S. Customs was contacted because the police officers involved suspected the adults of being involved in child pornography and knew the Customs Service to have a network of child pornography investigators, and of the existence of the Child Pornography and Protection Unit. SS/A Krietlow stated the two adults were well dressed white males. They had custody of six white children (boys and girls), ages three to six years. The children were observed to be poorly dressed, bruised, dirty, and behaving like animals in a public park in Tallahassee. The police were notified by a concerned citizen and all eight persons were taken into custody. The subjects were living out of a white 1979 Dodge van, Virginia license no. XHW 557. Upon being taken into custody, the adult white males refused to cooperate, one of whom produced a "business" card with a name on one side and a statement on the other. The statement indicated that the bearer knew his constitutional rights to remain silent and that he intended to do so. Upon interviewing the children, the police officers found that they could not adequately identify themselves or their custodians. Further, they stated they were enroute to Mexico to attend a school for "smart kids." SS/A Krietlow was further advised the children were unaware of the function and purpose of telephones, televisions and toilets, and that the children had stated they were not allowed to live indoors and were only given food as a reward.

After receiving the request from Tallahassee, SS/A Harrold contacted me while I was on official business at Customs Headquarters. He requested that I conduct computer checks on the Customs Child Pornography Unit data base. The checks were to be conducted on the names, addresses, and a vehicle provided by SS/A Krietlow. After conducting the computer checks, I made direct contact with SS/A Krietlow to inform him that all the checks were negative. At that time I was informed by SS/A Krietlow that the Tallahassee police had discovered large quantities of records, to include computer discs and a U.S. passport in the van. From some of these records the police had obtained tentative identification of the two adults, and partial identification of the children. Furthermore, the two Washington, D.C. addresses had been discovered through these documents, one of which was verified through the vehicle registration. I advised SS/A Krietlow I was leaving Headquarters and he would be receiving a response to the remainder of his request from SS/A Harrold. I then left as stated and proceeded to conduct other business in the District.

A short time later, at approximately 11:30 a.m., SS/A Harrold contacted me by radio, and advised me that a Detective Jim Bradley of the Washington, D.C. Metropolitan Police Department (MPD) was interested in the information provided by SS/A Krietlow, was in contact with Tallahassee, and would very probably be conducting search warrants in the area later in the day. He also informed me that U.S. Customs was invited to participate due to the continuing possibility of violations of law enforced by the Customs Service. As I was already in Washington, I terminated my other business and proceeded to make contact with Detective Bradley, Intelligence Division, MPD.

Upon contacting Detective Bradley, I learned that he had initiated an investigation on the two addresses provided by the Tallahassee Police Dept. during December of 1986. An informant had given him information regarding a cult, known as the "Finders" operating various businesses out of a warehouse located at 1307 4th St., N.E., and were supposed to be housing children at 3918/3920 W St., N.W. The information was specific in describing "blood rituals" and sexual orgies involving children, and an as yet unsolved murder in which the Finders may be involved. With the information provided by the informant, Detective Bradley was able to match some of the children in Tallahassee with names of children known alleged to be in the custody of the Finders. Furthermore, Bradley was able to match the tentative ID of the adults with known members of the Finders. I stood by while Bradley consulted with AUSA Harry Benner and obtained search warrants for the two premises. I advised acting RAC SS/A Tim Holloran of my intention to accompany MPD on the execution of the warrants, received his permission, and was joined by SS/A Harrold. SS/A Harrold accompanied the team which went to 1307 4th St, and I went to 3918/20 W St. 11

During the execution of the warrant at 3918/20 W St., I was

able to observe and access the entire building. I saw large quantities of children's clothing and toys. The clothing consisting of diapers and clothes in the toddler to pre-school range. No children were found on the premises. There were several subjects on the premises. Only one was deemed to be connected with the Finders. The rest were renting living space from this individual. He was identified as Stuart Miles SILVERSTONE, DOB/061941, U.S. Passport No. 010958991. SILVERSTONE was located in a room equipped with several computers, printers, and numerous documents. cursory examination of the documents revealed detailed instructions for obtaining children for unspecified purposes. The instructions included the impregnation of female members of the community known as Finders, purchasing children, trading, and kidnapping. There were telex messages using MCI account numbers between a computer terminal believed to be located in the same room, and others located across the country and in foreign locations. One such telex specifically ordered the purchase of two children in Hong Kong to be arranged through a contact in the Chinese Embassy there. Another telex expressed an interest in "bank secrecy" situations. Other documents identified interests in high-tech transfers to the United Kingdom, numerous properties under the control of the Finders, a keen interest in terrorism, explosives, and the evasion of law enforcement. Also found in the "computer room" was a detailed summary of the events surrounding the arrest and taking into custody of the two adults and six children in Tallahassee, Florida on the previous night. There were also a set of instructions which appeared to be broadcast via a computer network which advised participants to move "the children" and keep them moving through different jurisdictions, and instructions on how to avoid police attention.

One of the residents was identified as a Chinese National. Due to the telex discovered referencing the Chinese Embassy in Hong Kong, he was fully identified for future reference: WANG/Gengxin, DOB/092747, POB/Tianjin, People's Republic of China Passport No. 324999, entered the U.S. on January 22, 1987, admitted until December 31, 1987. He is in the U.S. as a graduate student in the Anatomy Department of Georgetown University. His Visa was issued on November 10, 1986, in London, England, number 00143.

During the course of the evening, I contacted Sector 4 to initiate a TECS check on SILVERSTONE, and initiate an archives check on him for the last four years. I also contacted SS/A Holloran to keep him advised of the proceedings and asked for and received permission to contact SS/A John Sullivan of the CPPU to query some names through the CPPU data base. SS/A Holloran told me he would call Southeast Region Headquarters to keep them posted on the proceedings as well. I later contacted SS/A Sullivan for the stated purpose, and in the discussion that followed, I gave him some background on the purpose of the request. I advised him that the information was not for dissemination at Headquarters, that Region was being notified,

and that Region would probably contact Headquarters later if deemed necessary. SS/A Sullivan assured me that the information would go no further until official notification was made by Region. No positive matches were obtained from the CPPU data base. I was later joined at the W Street address by SS/A Harrold. SS/A Harrold advised me that there were extremely large quantities of documents and computer equipment at the warehouse, and that MPD was posting officers inside the building there and sealing the building until morning, in which a second warrant for that premises would be obtained and executed. SS/A Harrold also advised me that the news media had been notified and had been waiting for the execution of the warrant at the 4th Street address. Detective Bradley later stated that the MPD Public Information Officer had been contacted by a Tallahassee reporter. When it became apparent the PIO had no information on the search warrants, the reporter contacted local media representatives and a check of public records containing the affidavits for the search warrants disclosed the locations and purpose of the warrants. Detective Bradley surmised that someone on the Tallahassee Police Department was the original source of information for the press. I advised SS/A Holloran of the involvement of the press, and he stated that he would, in turn, relay the information to Region. SS/A Harrold and I assisted in the transport of the evidence seized pursuant to the warrant and cleared MPD after the press left the area.

On Friday, 2/6/87, I met Detective Bradley at the warehouse on 4th Street, N.E. I duly advised my acting group supervisor, SS/A Don Bludworth. I was again granted unlimited access to the premises. I was able to observe numerous documents which described explicit sexual conduct between the members of the community known as finders. I also saw a large collection of photographs of unidentified persons. Some of the photographs were nudes, believed to be of members of Finders. There were numerous photos of children, some nude, at least one of which was a photo of a child "on display" and appearing to accent the child's genitals. I was only able to examine a very small amount of the photos at this time. However, one of the officers presented me with a photo album for my review. The album contained a series of photos of adults and children dressed in white sheets participating in a "blood ritual." The ritual centered around the execution of at least two goats. The photos portrayed the execution, disembowelment, skinning and dismemberment of the goats at the hands of the children. This included the removal of the testes of a male goat, the discovery of a female goat's "womb" and the "baby goats" inside the womb, and the presentation of a goat's head to one of the children.

Further inspection of the premises disclosed numerous files relating to activities of the organization in different parts of the world. Locations I observed are as follows: London, Germany, the Bahamas, Japan, Hong Kong, Malaysia, Africa, Costa Rica, and "Europe." There was also a file identified as

"Palestinian." Other files were identified by member name or "project" name. The projects appearing to be operated for commercial purposes under front names for the Finders. There was one file entitled "Pentagon Break-In," and others which referred to members operating in foreign countries. Not observed by me but related by an MPD officer, were intelligence files on private families not related to the Finders. The process undertaken appears to have been a systematic response to local newspaper advertisements for babysitters, tutors, etc. A member of the Finders would respond and gather as much information as possible about the habits, identity, occupation, etc., of the family. The use to which this information was to be put is still unknown. There was also a large amount of data collected on various child care organizations.

The warehouse contained a large library, two kitchens, a sauna, hot-tub, and a "video room." The video room seemed to be set up as an indoctrination center. It also appeared that the organization had the capability to produce its own videos. There were what appeared to be training areas for children and what appeared to be an altar set up in a residential area of the warehouse. Many jars of urine and feces were located in this area.


I should also mention that both premises were equipped with satellite dish antennas.

I discussed the course of action to be taken by MPD with Detective Bradley. He stated he was only interested in making the child abuse case(s). I was assured that all of the evidence would be available to U.S. Customs in furtherance of any investigative/criminal action pursued. MPD personnel were to begin around the clock review and sorting of the evidence until completed. Customs will have access after this is accomplished. This will include several U.S. Passports discovered during the search.

Upon leaving the 4th Street premises, I encountered a news media representative and was asked the reason behind U.S. Customs involvement in the investigation. I advised the reporter that I could not discuss anything and referred her to the RAC/DC. I left immediately thereafter.

There is no further information available at this time. It should take three to five days for all the information to be sorted, reviewed, logged by the MPD. I will maintain contact with Detective Bradley until the evidence is again accessible.

During the course of the search warrants, numerous documents were discovered which appeared to be concerned with international trafficking in children, high tech transfer to the United Kingdom, and international transfer of currency.

DETAILS OF INVESTIGATION:

On March 31, 1987, I contacted Detective James Bradley of the Washington, D.C. Metropolitan Police Department (MPD). I was to meet with Detective Bradley to review the documents seized pursuant to two search warrants executed in February 1987. The meeting was to take place on April 2 or 3, 1987.

On April 2, 1987, I arrived at MPD at approximately 9:00 a.m. Detective Bradley was not available. I spoke to a third party who was willing to discuss the case with me on a strictly "off the record" basis.

I was advised that all the passport data had been turned over to the State Department for their investigation. The State Department in turn, advised MPD that all travel and use of the passports by the holders of the passports was within the law and no action would be taken. This included travel to Moscow, North Korea, and North Vietnam from the late 1950's to mid 1970's.

The individual further advised me of circumstances which indicated that the investigation into the activity of the FINDERS had become a CIA internal matter. The MPD report has been classified secret and was not available for review. I was advised that the FBI had withdrawn from the investigation several weeks prior and that the FBI Foreign Counter Intelligence Division had directed MPD not to advise the FBI Washington Field Office of anything that had transpired.

No further information will be available. No further action will be taken.

No action to be taken on the basis of this report.

CIA Experiments with Mind Control on Children

by Jon Rappoport

The CIA mind-control apparatus has been well-known since 1975, when 10 large boxes of documents were released pursuant to Freedom of Information Act requests.

Several good books were then written on the subject of the CIA program known as MK-ULTRA. Officially spanning ten years from 1952-62, MK-ULTRA involved the use of LSD on unwitting military and civilian subjects in the United States. LSD and more powerful compounds were given under duress as brainwashing and truth-serum drugs. The program's aim was to find drugs which would irresistibly bring out deep confessions or wipe a subject's mind clean and program him or her as "a robot agent."

In experimental test situations, people were given acid without their knowledge, then interrogated under bright lights with doctors sitting in the background taking notes. Threats would be made. The test subjects were told that their LSD "downer trips" would be extended indefinitely if they refused to reveal their closely-guarded military secrets. The people being interrogated in this way were CIA employees, U.S. military personnel and, abroad, agents suspected of working for the other side in the Cold War. Long-term, severe debilitation and several documented deaths resulted. Much, much more could be said about MK-ULTRA.

None of this prepared people for the explosive testimony made on March 15, 1993, in Washington, D.C., before the President's Committee on Radiation, however. In unpublicized sessions, New Orleans therapist Valerie Wolf introduced two of her patients who had uncovered memories of being part of extensive CIA brainwashing programs as young children (in one case, starting at age seven). Their brainwashing included torture, rape, electroshock, powerful drugs, hypnosis and death threats. According to their testimony, the CIA then induced amnesia to prevent their recalling these terrifying sessions.



Both Wolf and her patients stated that they recovered the memories of this CIA program without regression or hypnosis techniques. In other words, these patients spontaneously discovered this information about themselves and their pasts.

Although the committee was mainly concerned with radiation, they permitted Valerie and her patients to testify because, astonishingly, several doctors who had administered the mind-control experiments had also been identified by other Americans secretly exposed to radiation. Apparently there was a crossover.

Prominent names surfaced in the March 15 testimony: Richard Helms, former head of the CIA; Dr. Sidney Gottlieb, who ran MK-ULTRA and Dr. John Gittinger,

Gottlieb's protégé. These men and others were directly accused of participating in grisly mind-control efforts on children.

Predictably, this testimony received *no* media attention. I now have it all, including many pages submitted to the committee that will likely never be released as part of their final report. Only a small percentage of the pages were read aloud at the hearing. Included are corroborating statements from other therapists around the country and several of their patients. I have now released all of this testimony as a book, *U.S. Government Mind-Control Experiments: On Children*.

When the sickening shock starts to wear off, deeply disturbing questions flood one's mind: Just what was this CIA program? How extensive was it? What was its purpose?

From what I have been able to discover so far, many American children, as well as children from Mexico and South America, were used over a period of about 40 years, starting around 1948. In fact, the program may still be going on. Doctors and agents who administered it wanted to obtain control over the minds of these children, ostensibly to create superagents who wouldn't remember even what missions they

carried out, because of hypnotically induced amnesia (which could be removed by their controllers and re-installed at will).'

Children were trained as sex agents, for example, with the job of blackmailing prominent Americans—primarily politicians, businessmen and educators. A great deal of filming was done for this purpose. Eventually, people from the inner core of the CIA program filmed each other, and some of the centers where children were used as sex agents got out of control and turned into CIA-operated sex rings.

Some children were considered expendable and simply murdered.

One person who states that he was in this program as a child said, off the record:

"They tried out their brainwashing techniques on the kids from Mexico and South America. They were considered expendable. But on another echelon of the program, they went after the best and the brightest American kids. Making perfect agents to combat the Soviets wasn't, I don't think, their ultimate objective. I can't remember what that was."

At this point, I made a suggestion:

"Well, if they were choosing the best and brightest, maybe they figured these kids would one day rise to important positions in the society, and they wanted to gain long-term control over them, so they would be under their thumb, so they could tap them at will—a way of controlling the future society."

"Maybe," he said. "The Nazis gained control over the intelligentsia in Germany. That was a very key step in their dominance. That was the first thing they did."

"This smells very much like a Nazi program in the U.S.," I said. "I don't mean all the controllers were German, but the style of it, the insanity."

He said, "They brought over a lot of Nazi doctors after the war and not just to build rockets—for a lot of projects."

Other people who said that they had been used as children in the program remember that doctors with German accents were definitely present at the sessions.

One therapist, who shared this information informally with colleagues around the country, states that, so far, the oldest person she has heard of who was in the program is now 52; the youngest is now nine.

Since a number of people who were brainwashed, tortured and drugged in these experiments try to resolve their experiences in therapy, psychiatrists and other professional therapists are hearing these stories. They are told, for example, that CIA controllers sometimes dressed up in Satanic costumes to further traumatize the children, also providing a cover that wouldn't be believed if the children ever talked.

It is worth noting that there is a movement to discredit these "recovered" memories, and the most prominent group, the False Memory Syndrome Foundation (FMSF), has several board members with CIA or military-intelligence connections—including the notorious Dr. Louis "Jolly" West of UCLA, who tried to establish a center for "the study of vio-

lence" at the university in the 1970s. His center's specialty would have been psychosurgery, a horrendous melting of brain connections supposedly to curb people's "violent tendencies."

FMSF maintains that a person always remembers abuse done to him or her, and therefore any new recovery of it in therapy is false and must have been fabricated through misleading suggestions by the therapist. While it is certainly true that such inducement happens in therapy, the blanket statement that all recovered memory is invented is unsubstantiated.

In a written statement to Dr. Wolf that was included in her testimony to the president's committee, well-known researcher and psychiatrist, Colin Ross said,

Publicly available in my files include descriptions of administration of 150 mcg of LSD to children age 5-10 years on a daily basis for days, weeks, months, and in a few cases even years. Neurosurgeons at Tulane, Yale, and Harvard did extensive research on brain electrode implants with intelligence funding, and combined brain implants with large numbers of drugs including hallucinogens.

Ross based his report on his more than 20 years of investigating CIA mind control.

Chris De Nicola, one of Dr. Wolf's patients who testified before the president's committee, named her controller as a Dr. Greene, a name reported by several other mind-control subjects. It may well be that this name was a cover used by a various CIA and military-contracted experimenter-torturers. Here is a quote from her testimony:

[Dr. Greene] used me in radiation experiments both for the purpose of determining the effects of radiation on various parts of my body and to terrorize me as an additional trauma in the mind control experiments. [She was eight years old.]

The rest of the experiments took place in Tucson, Arizona, out in the desert. I was taught how to pick locks, be secretive, use my photographic memory to remember things and a technique to withhold information by repeating numbers to myself. [She is obviously talking about being trained as an agent.]

Dr. Greene moved on to wanting me to kill dolls that looked like real children. I stabbed a doll with a spear once after being severely tortured, but the next time I refused. He used many torture techniques but as I got older I resisted more and more.

CONCEPT

He often tied me down in a cage which was near his office. Between 1972 and 1976 he and his assistants were sometimes careless and left the cage unlocked. Whenever physically I would sneak into his office and found files with reports and addresses of CIA and military personnel. Included in these files were project, subproject, subject and experiment names with code numbers for radiation and mind-control experiments which I have submitted in my written documentation. I was caught twice and Dr. Greene tortured me ruthlessly with electric shock, drugs, spinning me on a table, putting shots in my stomach, in my back, dislocating my joints and hypnosis techniques to make me feel crazy and suicidal.

Is there a precedent for this kind of sadistic treatment by CIA and military personnel? Indeed there is. Here is a quote from the introduction to my book, U.S. Government Mind-Control Experiments On Children. It contains information from reliable published sources, such as The Search for the Manchurian Candidate, by John Marks; Acid Dreams, by Martin Lee and The Mind Manipulators, by Alan Schefflin. In part, these authors derived their information on the CIA and MK-ULTRA from the ten boxes of information released suddenly in 1975 by the agency in response to Freedom of Information Act requests:

Dr. Robert Heath of Tulane University, as early as 1955, working for the Army, gave patients LSD while he had electrodes implanted deep inside their brains.

Canadian researcher, Dr. Ewan Cameron, under long-term CIA contract, attempted to depattern and reprogram his psychiatric patients' personalities wholesale. He started with 15 to 65 days of "sleep therapy" during which a patient was kept under nearly 24 hours a day, through the administration of cocktails of Thorazine, Nembutal, Seconal, Veronal, and Phenergan. Throughout this sleep period, the patient would be awakened two or three times a day for electroshock treatments, given at an intensity 20-40 times the "normal" convulsion-producing strength.

In the mid-1950s, Paul Hoch, M.D., a man who would become Commissioner of Mental Hygiene for the state of New York, then a lobbyist in the field for the CIA, gave a "pseudoneurotic schizophrenic" patient mescaline. The patient had a not-unfamiliar heaven-and-hell journey on the compound. But Hoch followed this up with a transorbital leucotomy. Hoch also gave a patient LSD, and a local anesthetic, and then proceeded to remove pieces of cerebral cortex, asking at various moments whether the patient's perceptions were changing.

Claudia Mullin, the other of Dr. Wolf's patients who testified before the President's Committee on Radiation, said her experiences with CIA mind-control experiences began when she was seven years old:

In 1958, I was to be tested. They told me, by some important person, that I was going to a place called the 'Society' [the Human

any of their questions. Then, since the test 'might hurt,' I would be given 'shots, x-rays, and a few jolts of electricity.' I was instructed 'not to look at anyone's face too hard and to ignore names,' as this was 'a very secret project' but to be brave and all those things would help me forget.

A Dr. John Gittinger tested me and Dr. Cameron gave me the shocks and Dr. Greene the x-rays. . . . By the time I left to go home, just like every time from then on, I would recall nothing of my tests or the different doctors. I would only remember whatever explanations Dr. Robert G. Heath [of Tulane Medical School] gave me for the odd bruises, needle marks, burns on my head and fingers and even the genital soreness. I had no reason to believe otherwise. Already, they had begun to control my mind!

The next year, I was sent to a place in Maryland called Deep Creek Cabins to learn how to 'sexually please men.' Also, I was taught how to coerce them into talking about themselves. It was Richard Helms (Deputy Director of the CIA), Dr. Gottlieb, Captain George White and Morse Allen who all planned on filming as many high government and agency officials and heads of academic institutions and foundations as possible. . . . I was to become a regular little 'spy' for them after that summer, eventually entrapping many unwitting men, including themselves, all with the use of a hidden camera. I was only nine when this kind of sexual humiliation began.

Captain George White was a notorious agent for the CIA. He set up a brothel in San Francisco in the 1960s and, using hidden cameras, filmed men having sex with prostitutes. The men's drinks were "spiked" with LSD. In 1950, Morse Allen, another important CIA man, was appointed head of Project BLUEBIRD, another CIA mind-control program.

Ms. Mullin states that she was adopted when she was two years old. By the time she reached seven she had already been abused extensively by her mother. Her mother apparently turned her over for "testing" to CIA-connected people, and Claudia then entered a 27-year period of what can only be called enslavement. Claudia states that she has been monitored, that she is still monitored and watched by agency-related people, including a medical doctor. Now living in New Orleans, she has given information to local police authorities about her situation. In her testimony to the president's committee, Claudia remarked,

Although the process of recalling these atrocities is certainly not an easy task, nor is it without some danger to myself and my family. . . . I feel the risk is worth taking.

Claudia's therapist, Dr. Wolf, has written to the president's committee,

To the best of my knowledge, [Claudia] has read nothing about mind control or CIA covert operations. Since she decided to listen carefully and remember as much as she could about conversations among the researchers, her memories are extraordinarily complete. I have sent written copies of

Manipulators; for validation and he has confirmed that she has knowledge of events and people that are not published anywhere, that some of her memories contain new information and that some are already known and published. Some of her memories have been confirmed by family members. She has also shown me old scrapbooks where she wrote notes to remember what was happening to her and hid the notes under pictures in the scrapbook.

I spoke with Alan Schefflin in May of this year. He said he had found one piece of information Claudia had mentioned in her recollections that had no precedent in published material. It involved a connection between two government researchers.

This is just the tip of the iceberg on the 130 pages of testimony given before the President's Committee on Radiation, and it is also just the beginning of a history that will undoubtedly widen in the coming months and years. Dr. Wolf told me that when word got around she was going to testify before the president's committee, she was contacted by about 40 therapists "in just the 10 days leading up to my trip to Washington." The therapists had heard similar CIA mind-control stories from their own patients. Many of these professionals are afraid to go on the record about their patients' stories, as censure from their professional societies is a reality. The political mood these days is not conducive to granting an aura of credibility to revelations of CIA brain-washing.

So what else is new?

CIA's Gottlieb Ran LSD Mind Control Testing

■ Scientist, who died at 80, oversaw invention of devices for assassination and gave 'acid' to human guinea pigs.

James Bond had Q, the scientific wizard who supplied 007 with dazzling gadgets to deploy against enemy agents. The Central Intelligence Agency had Sidney Gottlieb, a Bronx-born biochemist with a PhD from Caltech whose job as head of the agency's technical services division was to concoct the tools of espionage: disappearing inks, poison darts, toxic handkerchiefs.

Gottlieb once mailed a lethal handkerchief to an Iraqi colonel and personally ferried deadly bacteria to the Congo to kill Prime Minister Patrice Lumumba. It wasn't his potions that eventually did in the two targets, but Gottlieb, once described by a colleague as the ultimate "good soldier," soldiered on.

Poisons and darts were not his sole preoccupation during 22 years with the CIA. He labored for years on a project to unlock and control the mysterious powers of lysergic acid diethylamide, or LSD. Could it be a potent spy weapon to weaken the minds of unwilling targets?

In the 1950s and 1960s, answering that question was one of Gottlieb's missions in MKULTRA, the code name for the agency's secret experiments to probe the effects of mind-altering drugs. Chief among them was LSD, discovered by Dr. Albert Hofman, a Swiss chemist, in 1943.

1943.

By the early 1950s, the CIA, fearful of LSD falling into Soviet hands, had cornered the market on the drug, which in minute doses could produce overwhelming sensations ranging from kaleidoscopic acuity to temporary insanity. The agency also started to fund research, covertly funneling hundreds of thousands of dollars to academics in prestigious institutions around the country who tried the drug themselves and reported the results to Gottlieb.

Gottlieb and his associates in MKULTRA also took LSD "trips," although the concept of tripping would not enter the American lexicon for another decade. They laced coffee with LSD and served it to each other without warning, then observed each other's reactions. Later Gottlieb expanded the field tests to subjects outside the agency—drug addicts, prostitutes, prisoners, mental patients—people who were unlikely to complain and even less likely to be believed if they did. Among the dosed were hookers and their clients in a CIA-sponsored brothel in San Francisco, later the epicenter of the LSD explosion.

One human guinea pig was subjected to an astounding 77-day trip. Some subjects suffered chronic mental problems after being dosed. One person—an Army germ warfare researcher—sank into dark depression and paranoia, leaping to his death from the 10th floor of a New York hotel several days after being slipped an LSD Mickey Finn at a CIA retreat. The CIA covered up its role in his demise for two decades, and barely reprimanded Gottlieb

In the early 1960s, Gottlieb was promoted to the highest deputy post in the technical services operation. By 1967, he had risen to the top of the division, guided by his longtime CIA mentor, Director Richard Helms. At that time, LSD

was not a secret anymore. While the CIA was still examining the drug's possibilities as a means of mind control, many young Americans were dropping the hallucinogen as a vehicle of mind expansion and recreation. America was tuning in, turning on and dropping out, thanks, in part, to the CIA's activism in the '50s in the name of national security.

It was not until 1972 that Gottlieb called a halt to the experiments with psychedelics, concluding in a memo that they were "too unpredictable in their effects on individual human beings . . . to be operationally useful."

He retired the same year, spending the next few decades in eclectic pursuits that defied the stereotype of the spy. He went to India with his wife to volunteer at a hospital for lepers. A stutterer since childhood, he got a master's degree in speech therapy. He raised goats on a Virginia farm. And he practiced folk dancing, a lifelong passion despite the handicap of a clubfoot.

A malignant, real-life Q, or an eccentric genius whose intentions were honorable and just?

Gottlieb led the agency in 149 mind control experiments, of which about 25 were conducted on unwitting subjects. According to the survivor of one victim, the way Gottlieb duped American citizens was nothing but despicable.

Less black and white in his assessment is John Marks, author of the definitive book on the CIA's mind control programs, "The Search for the Manchurian Candidate." Marks sees Gottlieb as an unabashed patriot who nonetheless "crossed the same ethical lines we hanged German doctors in World War II for."

There is also the view of former CIA psychologist John Gittinger, who says his close friend was a gentle man whose actions were widely misunderstood. The agency's LSD experiments bloomed in the era of Josef Stalin and Sen. Joseph McCarthy, and "during that time of Cold War," Gittinger said recently from his home in Norman, Okla., "the attitude we had and the agency had was we were still fighting a war. And when you are fighting a war, you do things you might not ordinarily do."

Gottlieb died on March 7 in Washington, Va. He was 80. His family did not divulge the cause of his death.

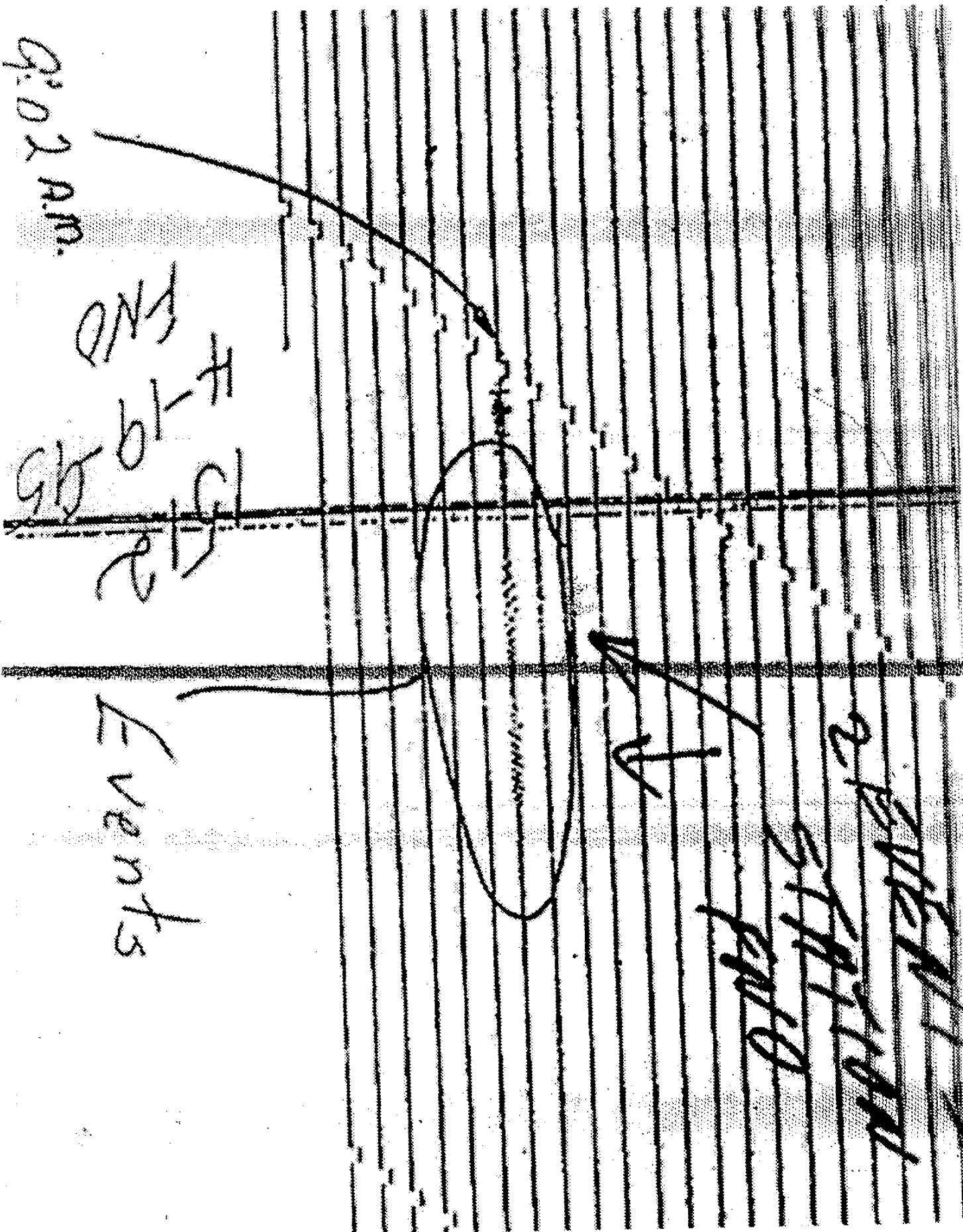

DHAHRAN, Saudi Arabia — Staff Sgt. Alfredo Guerrero saw it coming, unfolding before him like the nightmare his training courses had etched.

The Saudi base, where American, British and French troops are housed in a complex called Khobar Towers, was already under a heightened state of alert after warnings of possible attacks on Americans.

On Tuesday night, Guerrero and two other Air Force security policemen were patrolling the roof of an eight-story barracks in the northernmost corner of Khobar Towers when a large gasoline truck and a passenger car pulled up to the perimeter fence.

The driver ran from his truck and threw himself into the car, which sped away, and Guerrero knew immediately that it was a bomb.

He and his fellow officers rushed down through the building urging those inside to evacuate. They had perhaps three minutes for their task.

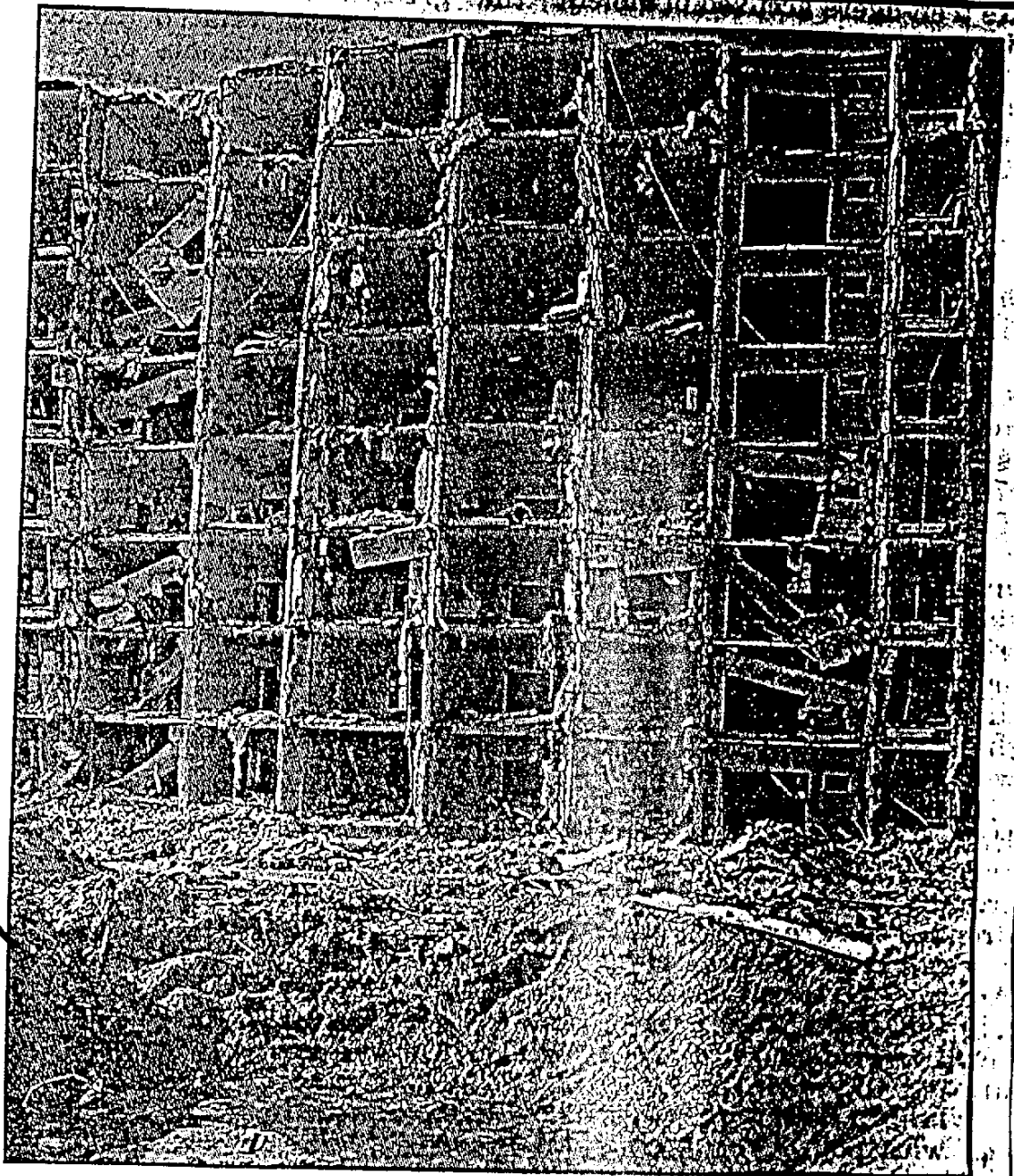
Guerrero had only made it down two floors when the explosion struck, ripping the face off the building and killing 19 American servicemen. More than 400 other people were injured, 250 of them American.

"Many are alive today because of his heroism," said Secretary of State Warren Christopher, who canceled a trip intended to help restart the Middle East peace effort to come here and see the latest victims of terrorism.

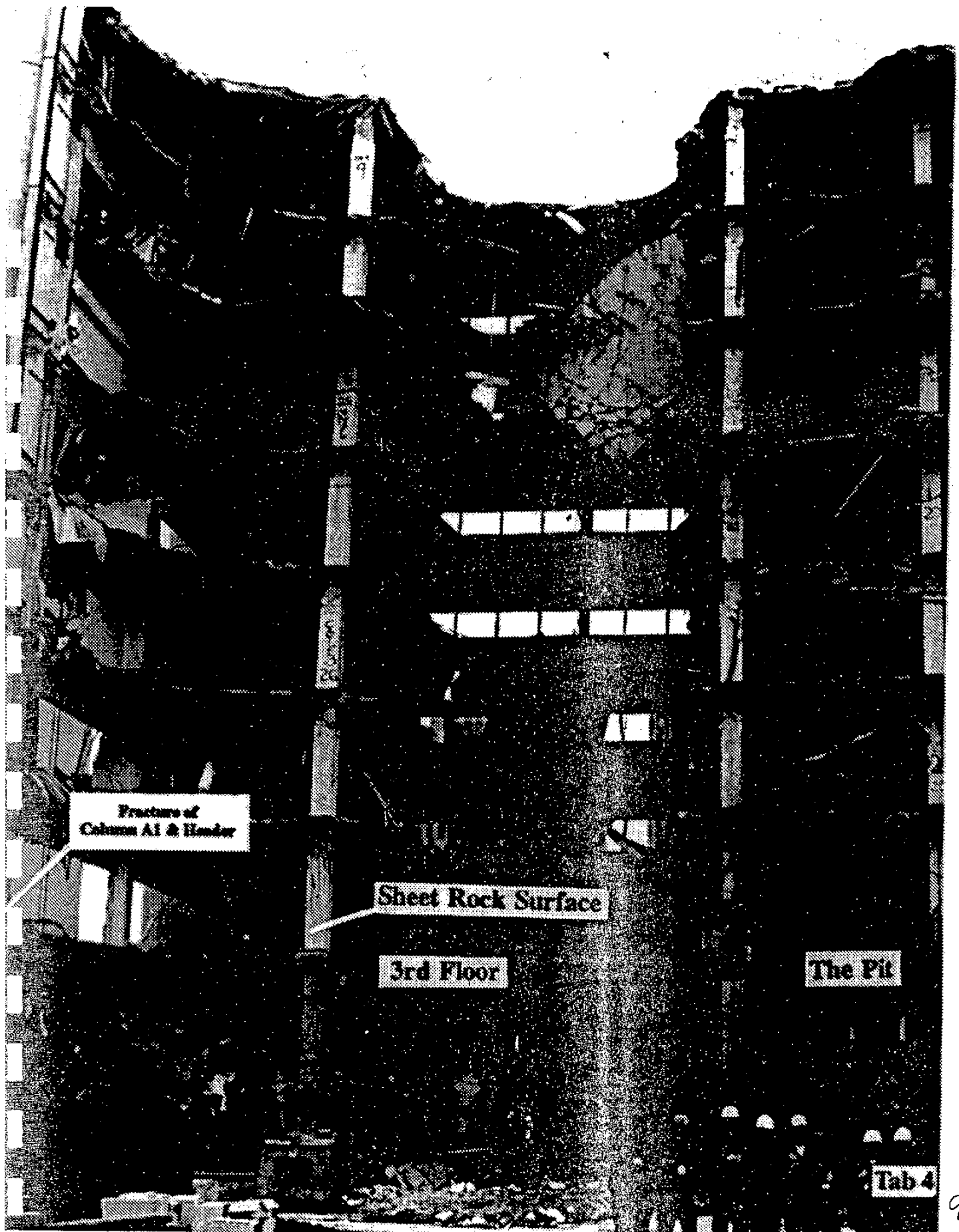
Prince Saud Faizal, the Saudi foreign minister, broke in. "This gentleman's name is Staff Sgt. Guerrero, and we're very grateful to him."

Cover-up claim in hunt for Oklahoma 'witness'

A couple grieving for grandchildren killed in the bombing last year think they have identified a name missed by the huge resources of the FBI, says Ambrose Evans-Pritchard

WHILE President Clinton is in Europe demanding a tougher response to terrorism, his own government is having trouble getting to the bottom of the Oklahoma bombing, the most deadly act of terrorism ever committed on US soil.

The Oklahoma investigation is losing credibility fast, with talk of a cover-up now reaching fever pitch. Glenn and Kathy Wilburn, who lost two grandchildren in the blast, have accused the Justice Department of playing politics with their grief.

Conducting their own investigation they have already raised doubts about the official story implicating Tim McVeigh, the chief suspect, in the April 1995 Oklahoma City blast in which 168 died.

Now the Wilburns believe they have tracked down the elusive witness known as "John Doe II", the named, tattooed, muscular man said to have been with McVeigh when he allegedly rented the Ryder truck used in the bombing.

The man they name has been identified from a photo by one of the witnesses who helped draw up the artist's impression of John Doe II. Several other witnesses have said they think the photo is of the same person.

If the witnesses are right, the man is a former university student from Philadelphia named Michael Brescia. Over the last month some of the major US newspapers and TV networks have been searching nationwide for him, with no success.

It is remarkable that the FBI has shown so little interest in Brescia, if the Wilburns are correct. The search for John Doe II involved half of the FBI's entire staff of special agents. The vast investigative machinery of the US government had not been mobilised in such a way since the assassination of President Kennedy. Apparently, it found nothing. After two months the Justice Department announced that the sighting of John Doe II was a simple matter of confusion. The witness was an innocent soldier who happened to visit the Ryder rental office in Junction City the day after McVeigh, said the official statement.

This account is disputed vehemently by the three witnesses at the Ryder agency who said they saw McVeigh with John Doe II.

told the FBI that they knew who the John Doe II in the artist's impression was. One, a college student named Caitlin Lawson, was a close friend of McVeigh. The other was Bernadette Conne Smith.

In a confidential statement to the FBI, dated April 23, Smith said her daughter, "dated McVeigh for two years". Lawson says that she was just a friend, but admits to having attended parties in Kansas where McVeigh was present. The staff and consultants of this office continue to analyze as yet unidentified human tissue recovered from the Murrah Building bombing.

Among this tissue is a traumatically amputated left thigh and lower leg recovered on May 30, 1995. This leg was clothed in a black military type boot, two socks, and an olive drab blousing strap. Anthropologic analysis of this specimen reveals the individual to be light skinned, dark haired, probably less than 30 years of age, male (75% probability), and having an estimated height of 66 plus or minus 3 inches. This leg has not been matched to any of the known victims or survivors.

DNA and other scientific analyses on this and other tissue continue at our office and in the FBI laboratories in Washington D.C. Once these scientific investigations are completed further information will be released.

Probe: CIA didn't know of Arkansas smuggling

WASHINGTON — An internal CIA investigation found no evidence the intelligence agency knew anything about alleged drug smuggling activities at an airport in Mena, Ark., where the intelligence agency once held a secret training exercise.

"No evidence has been found that the CIA was associated with money laundering, narcotics trafficking, arms smuggling or other illegal activities at or around Mena, Ark., at any time," said the report, made public Friday.

The investigation was conducted by Frederick P. Hitz, the CIA inspector general. The agency released a six-page unclassified summary of his findings.

CIA Director John Deutch ordered the investigation last spring in response to a request in February from House Banking Committee Chairman Jim Leach, R-Iowa. Leach's panel is conducting its own investigation of alleged money laundering in the Mena area, stemming from the committee's Whitewater inquiry and related issues.

Dave Runkel, a spokesman for the committee, said allegations that the CIA was somehow involved in running guns to Nicaragua and that CIA-chartered planes may have been used to smuggle cocaine into the United States date back to the Reagan and Bush administrations.

A new book, "Boy Clinton," by R. Emmett Tyrrell, editor of the conservative American Spectator magazine, alleges that President Clinton, then the governor of Arkansas, knew about illegal activities at Mena.

At a news conference in 1994, Clinton was asked about the allegations and replied that he knew nothing about any illegal activity at the Mena Intermountain Airport.

"The airport in question, and all the events in question, were the subject of state and federal inquiries," he said. "It was primarily a matter for federal jurisdiction. The state really had next to nothing to do with it."

The CIA's Hitz said "no evidence has been found to indicate that CIA or anyone acting on its behalf participated in, or otherwise had knowledge of, any illegal or improper activities in Mena, Ark., or the area north of Mena known as Nella, Ark."

The inspector general said the agency was involved in two activities at the airport over a three-year period.

The CIA engaged in a joint training operation at the airport with another federal agency, the report said.

Also, the agency contracted with businesses at the airport "to perform routine aviation-related services on equipment owned by the CIA," he said.

WASHINGTON — The CIA admits it deals with some unsavory people — possibly even drug dealers — as it collects secrets.

But investigators so far have been unable to prove — or refute — the explosive allegation that the agency was linked in the mid-1980s to the spread of crack cocaine in America's poor black neighborhoods.

A three-part series called "Dark Alliance," published in August by the San Jose Mercury News in California, said a Bay area drug ring sold tons of cocaine to Los Angeles street gangs and funneled millions in drug profits to a CIA-run guerrilla army.

The series sparked widespread anger in the black community toward the CIA. In a lengthy article Friday, however, The Washington Post challenged several of the findings by the Mercury News.

The Mercury News stood by its report, saying the basic allegation that people associated with the CIA trafficked in cocaine had not been challenged.

The series traced the crack cocaine explosion to two Nicaraguan cocaine dealers, Danilo Blandon and Norwin Meneses, who were civilian leaders of an anti-communist commando group formed and run by the CIA during the 1980s.

“We are going to have to ask our case officers to be in some very dangerous places with some very unsavory characters,” Deutch recently told lawmakers. In the hypothetical case of a known terrorist or narcotics trafficker willing to provide sensitive intelligence, Deutch said, “there is no intent on our part to constrain or stop or slow recruiting of that asset.”

As investigations by the CIA, Justice Department and Congress proceed, the Mercury News series has taken on a life of its own, circulating on fax and copy

machines and on talk radio, particularly in black neighborhoods beset by crack abuse. Black leaders have held protests and demanded investigations.

“When you have a situation where you have people who can see the results of the drug right in front of them every day, and the people are generally distrustful of the government, when you put that in combination with this article, you have a formula for a tremendous amount of concern,” said Rep. Elijah Cummings, D-Md., a black congressman whose district includes poor minority sections of Baltimore.

One factor aggravating the anger among blacks, Cummings said, is the federal guideline that imposes a mandatory sentence of five years in prison for possession of 5 grams of crack cocaine whereas no such minimum exists

for powdered cocaine, a more expensive drug less likely to be found in the ghetto.

Rep. Julian Dixon, D-Calif., a fellow member with Cummings of the Congressional Black Caucus and of the House Intelligence Committee, said some in the black community may be too quick to believe and exaggerate allegations raised in the newspaper series. At the same time, Dixon said, the voluminous record of the Iran-Contra scandal contains repeated references to drug trafficking connections among the CIA-backed Contra forces in Nicaragua.

“It's going to be very difficult to prove that the CIA was directly involved or aided and abetted” crack cocaine trafficking, Dixon said. “But just as serious is if they knew and ignored it, or just turned their head and said, ‘Just don't tell me about it.’”

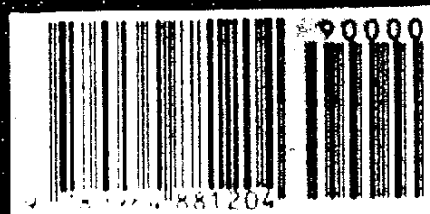

Report: U.S. aware 900 POWs left behind

NEW YORK — The United States was aware that more than 900 American servicemen were still being held by North Korea at the end of the Korean War, The New York Times reported in today's editions.

The revelation fuels growing speculation that American prisoners might still be alive and in custody in North Korea, the newspaper said.

Historians suggest the Eisenhower Administration decided not to make public much of its intelligence on the issue for fear of whipping up hysteria among Americans who would have demanded the prisoners' return.

"In the nuclear age, Eisenhower could not risk telling the Russians or Chinese that we're willing to go to all-out war to get our prisoners back," said Al Santoli, a congressional investigator who helped gather recently declassified documents.

The documents were obtained from the Dwight D. Eisenhower Presidential Library and other government depositories by the House National Security subcommittee on military personnel.

The subcommittee is scheduled to hold hearings on the issue today.

The North Korean government has said it is not holding any Americans. A number of American defectors are known to live in Pyongyang, the North Korean capital.

In June a Defense Department analyst testified that on the basis of a recent flurry of very compelling reports he believed that as many as 15 Americans were still being held in North Korea, the Times said.

The Defense Department did not dismiss the analyst's report entirely but said it has no clear evidence any Americans are being held against their will.

One of those scheduled to testify today is retired Col. Philip Corso, a former military aide to President Eisenhower. In a statement prepared for delivery before the House panel, Corso said "In the past I have tried to tell Congress the fact that in 1953, 500 sick and wounded American prisoners were within 10 miles of the prisoner exchange point at Panmunjom but were never exchanged."

Tapes Depict Proposal to Thwart Bomb Used in Trade Center Blast

NEW YORK, Oct. 27 — Law-enforcement officials were told that terrorists were building a bomb that was eventually used to blow up the World Trade Center, and planned to thwart them by secretly substituting harmless powder for the explosives, an informer said after the blast.

The informer was to have helped the letters build the bomb and supply the fake powder, but the plan was called off by an F.B.I. supervisor who had other ideas about how the informer, Emad A. Salem, should be used, the informer said.

The account, which is given in the transcript of hundreds of hours of tape recordings Mr. Salem secretly made of his talks with law-enforcement agents, portrays the authorities as in a far better position than previously known to foil the Feb. 26 bombing of New York City's tallest towers. The explosion left six people dead, more than 1,000 injured and damages in excess of half a billion dollars.

Mr. Salem, a 43-year-old former Egyptian army officer, was used by the government to penetrate a circle of Muslim extremists now charged in two bombing cases: the World Trade Center attack and a foiled plot to destroy the United Nations, the Hudson River tunnels and other New York City landmarks. He is the crucial witness in the second bombing case, but his work for the Government was erratic, and for months before the trade center blast, he was feuding with the F.B.I.

Supervisor 'Messed It Up'

After the bombing, he resumed his undercover work. In an undated transcript of a conversation from that period, Mr. Salem recounts a talk he had had earlier with an agent about an unnamed F.B.I. supervisor who, he said, "came and messed it up."

"He requested to meet me in the hotel," Mr. Salem says of the supervisor. "He requested to make me to testify and if he didn't push for that, we'll be going building the bomb with a phony powder and grabbing the people who was involved in it. But since you,

we didn't do that."

The transcript quotes Mr. Salem as saying that he wanted to complain to F.B.I. headquarters in Washington about the bureau's failure to stop the bombing, but was dissuaded by an agent identified as John Anticev.

"He said, I don't think that the New York people would like the things out of the New York office to go to Washington, D.C.," Mr. Salem said Mr. Anticev had told him.

Another agent, identified as Nancy Floyd, does not dispute Mr. Salem's account, but rather, appears to agree with it, saying of the New York people: "Well, of course not, because they don't want to get their butts chewed."

Mary Jo White, who, as the United States Attorney for the Southern District of New York is prosecuting defendants in two related bombing cases, declined today to comment on the Salem allegations or any other aspect of the cases. An investigator close to the case who refused to be identified further said, "We wish he would have saved the world," but called Mr. Salem's claims "figments of his imagination."

The transcripts, which are stamped "draft" and compiled from 70 tapes recorded secretly during the last two years by Mr. Salem, were turned over to defense lawyers in the second bombing case by the Government on Tuesday under a judge's order barring lawyers from disseminating them. A large portion of the material was made available to The New York Times.

In a letter to Federal Judge Michael B. Mukasey, Andrew C. McCarthy, an assistant United States attorney, said that he had learned of the tapes while debriefing Mr. Salem and that the informer had then voluntarily turned them over. Other Salem tapes and transcripts were being withheld pending Government review, of "security and other issues," Mr. McCarthy said. Kunstler Accuses U.S.

William M. Kunstler, a defense lawyer in the case, accused the Government this week of improper delay in handing over all the material. The transcripts he had seen, he said, "were filled with all sorts of Government misconduct." But citing the judge's order, he said he could not provide any de-

Mr. Salem's evident anguish at not being able to thwart the trade center blast is a recurrent theme in the transcripts. In one of the first numbered tapes, Mr. Salem is quoted as telling agent Floyd: "Since the bomb went off I feel terrible. I feel bad. I feel here is people who don't listen."

Ms. Floyd seems to commiserate, saying, "hey, I mean it wasn't like you didn't try and I didn't try."

In an apparent reference to Mr. Salem's complaints about the supervisor, Agent Floyd adds, "You can't force people to do the right thing."

The investigator involved in the case who would not be quoted by name said that Mr. Salem may have been led to believe by the agents that they were blameless for any mistakes. It was a classic agent's tactic, he said, "blame the boss for all that's bad and take credit for all the good things."

'You Saw This Bomb'

In another point in the transcripts, Mr. Salem recounts a conversation he said he had with Mr. Anticev, saying, "I said 'Guys, now you saw this bomb went off and you both know that we could avoid that.'" At another point, Mr. Salem says, "You get paid, guys, to prevent problems like this from happening."

Mr. Salem talks of the plan to substitute harmless powder for explosives in the trade center bombing during another conversation with agent Floyd. In that conversation, he recalls a previous discussion with Mr. Anticev.

"Do you deny," Mr. Salem says he told the other agent, "your supervisor is the main reason of bombing the World Trade Center?" Mr. Salem said Mr. Anticev did not deny it. "We was handling the case perfectly well until the supervisor came and messed it up, upside down."

Studied for Signs of Illegality

The transcripts are being closely studied by lawyers looking for signs that Mr. Salem and the law enforcement officials, in their zeal to gather evidence, may have crossed the legal line into entrapment, a charge that defense counsel have already raised.

But the transcripts show that the officials were concerned that by associating with bombing defendants awaiting trial in the Metropolitan Correctional Center, Mr. Salem might have been accused of spying on the defense.

President Clinton, seeking to expand the government's power against terrorism in the wake of the Oklahoma bombing, says he won't ignore individual rights.

"I don't think we have to give up our liberties," Clinton said Sunday on CBS's *60 Minutes*. "We do have to take more seriously threats to our liberties."

Clinton has put all federal buildings on a heightened security alert until a study of their vulnerability is completed.

He urged formation of a counterterrorism unit headed

by the FBI. And he ordered preparation of a presidential directive authorizing further steps to combat terrorism.

Senate Judiciary Committee Chairman Orrin Hatch, R-Utah, says he has drafted provisions calling for expanded FBI authority to track international and domestic terrorists.

And House Judiciary Committee Chairman Henry Hyde, R-Ill., says he's ready to write legislation that includes the president's proposals.

For two months, an anti-terrorism bill proposed by Clinton stalled in Congress.

Last Wednesday's bombing suddenly changed that.

The proposal, to be rewritten combining several bills in-

roduced by House and Senate leaders, is on a fast track toward bipartisan passage.

Clinton's bill, originally aimed at international terrorism, will include domestic terrorism. The bill:

- ▶ Establishes a Domestic Counterterrorism Center, headed by the FBI, and creates a special fund for infiltrating suspected terrorist groups.

- ▶ Gives the FBI increased authority to search phone logs and hotel and motel registers, and greater access to credit-card records.

- ▶ Creates a federal crime of "international terrorism committed within the United States," punishable by death if someone dies as a result of a terrorist's act.

- ▶ Expands federal wiretapping and surveillance powers.

- ▶ Forbids fund-raising by organizations the president designates as terrorist.

- ▶ Permits evidence from secret sources to be used in deportation proceedings.

- ▶ Allows the Justice Department to investigate crimes based on the political beliefs and associations of suspects.

Arab-Americans say the proposals ignite anti-Arab sentiment. Civil libertarians say they trample constitutional rights. Their leaders discuss their objections today with Justice Department officials.

"I can understand their concerns, but they're not valid,"

Clinton's national security adviser, Tony Lake, says. "It's aimed at organizations that are supporting terrorism, and we are unapologetic about opposing those organizations."

House Speaker Newt Gingrich, R-Ga., says Congress should make it easier to charge people who are aware of terrorist plots, even if they're not directly involved in them.

"I think what a free society has to do," Gingrich says, "is draw a very sharp distinction between free speech and criminal activity."

Gingrich was angry Saturday, after a visit to the Oklahoma bombing site, when a reporter asked if GOP criticism of government bureaucrats

had encouraged the attack on a government building.

"It is grotesque to suggest that anybody in this country who raises legitimate questions

about the size and scope of the federal government has any implication in this," he said.

McVeigh's Lawyers Claim Bombing Cover-up

New evidence suggests the U.S. government is involved in a massive cover-up concerning the facts behind the bombing of the Alfred P. Murrah Federal Office Building in Oklahoma City.

At least one member of the federal grand jury that handed down indictments against Timothy J. McVeigh and Terry L. Nichols—accused bombing suspects in the April 19 Oklahoma City bombing—has spoken out against grand jury proceedings.

The juror has revealed the indictments were "fatally flawed" and federal prosecutors withheld vital information from the grand jurors impaneled to hear testimony.

As a result, Steven Jones and Richard H. Burr, lawyers representing McVeigh, have filed a motion seeking dismissal of the indictment against their client, charging misconduct and a breach of grand jury secrecy.

The grand juror, upset with the course of the proceedings, discussed his concerns with, at least two publications: the monthly magazine *Media Bypass* and the *Daily Oklahoman* in Oklahoma City, as well as his representative in Congress and several other people.

MYSTERY MAN

The grand juror is particularly upset that prosecutors stifled the panel from asking questions about the bombing investigation and particularly about the so-called "John Doe No. 2," who has never been located and whom federal investigators now contend never existed.

The government made a deliberate attempt to cause the grand jury to focus only upon an indictment of Nichols and McVeigh and purposely did not bring to the grand jury evidence which would establish the role of others or a larger conspiracy," Jones said in his motion to dismiss the indictment against McVeigh.

The grand juror has stated prosecutors did not seem interested in pursuing leads concerning John Doe No. 2 and did not want members of the panel asking questions about him.

The grand juror further stated he is "satisfied that the government" knows the identity of the mysterious man linked to the case since a few days after the actual bombing.

The panel member also stated federal prosecutors duped Michael Fortier of Arizona into pleading guilty to playing a lesser part in the bombing. They also threatened that his wife, Lori, would be sent to jail.

FORTIER RAILROADED?

"They had zero on this poor old boy, this little boy and girl in Arizona," the grand juror said. But prosecutors insisted "you've got to [confess] so we don't send your wife to jail." All they had him on was transporting stolen guns interstate.

The *New York Times* has reported the juror contended that prosecutors intimidated the jurors and pressed them to confine the investigation to the activities of Mr. McVeigh and the other defendant in the case, Terry L. Nichols, to meet a deadline set by federal guidelines on providing speedy trials.

In the motion for dismissal, Jones said "the government attempted to prevent the grand jurors from acting as a free and independent body" and "discouraged or precluded grand juror requests for presentation of evidence, and discouraged relevant questions."

INTIMIDATION

"Because of feelings of intimidation, coercion and lack of independence, members of the grand jury began to contact at least three, and possibly more outside media sources, members of the legislature and other persons who had experience in law enforcement in order to voice their complaints."

Jones said the juror's complaints indicated the prosecutors "circumvented grand jury independence by limiting the scope of its inquiry, withholding anything that might indicate a broader conspiracy or a different conspiracy."

The grand juror also indicated that some members of the panel believed Nichols, an Army pal of McVeigh, tried to stop the truck bombing. "Nichols got charged with everything McVeigh did, and he shouldn't have," the grand juror stated.

Nichols "was an unwilling accomplice in the end... He backed out. He didn't want to do it. He refused at one point to help McVeigh build the bomb."

the difference between live and dead matter. We pass by with deserved contempt the pseudo-scientific experiments of American charlatans who claim to have established that weight is lost at the moment of death, and the unsupported statements of alleged clairvoyants that they have seen the soul issuing like a vapour from the mouth of persons *in articulo mortis*; but his experiences as an explorer have convinced the Master Therion that meat loses a notable portion of its nutritive value within a very few minutes after the death of the animal, and that this loss proceeds with ever-diminishing rapidity as time goes on. It is further generally conceded that live food, such as oysters, is the most rapidly assimilable and most concentrated form of energy. Laboratory experiments in food-values seem to be almost worthless, for reasons which we cannot here enter into; the general testimony of mankind appears a safer guide.

It would be unwise to condemn as irrational the practice of those savages who tear the heart and liver from an adversary, and devour them while yet warm. In any case it was the theory of

"kill" steel, and "raise it from the dead"; and flies drowned in ice-water can be resuscitated. That it should be impossible to create high organic life is scientifically unthinkable, and the Master Therion believes it to be a matter of few years indeed before this is done in the laboratory. Already we restore the apparently drowned. Why not those dead from such causes as syncope? If we understood the ultimate physics and chemistry of the brief moment of death we could get hold of the force in some way, supply the missing element, reverse the electrical conditions or what not. Already we prevent certain kinds of death by supplying wants, as in the case of Thyroid.

1. One can become actually drunk on oysters, by chewing them completely. Rigor seems to be a symptom of the loss of what I may call the Alpha-energy and makes a sharp break in the curve. The Beta and other energies dissipate more slowly. Physiologists should make it their first duty to measure these phenomena; for their study is evidently a direct line of research into the nature of Life. The analogy between the living and complex molecules of the Uranium group of inorganic and the Protoplasm group of organic elements is extremely suggestive. The faculties of growth, action, self-recuperation, etc., must be ascribed to similar properties in both cases; and as we have detected, measured and partially explained radioactivity, it must be possible to contrive means of doing the same for Life.

On the other hand, the practice of torturing animals to death in order to obtain the elemental as a slave is indefensible, utterly black magic of the very worst kind, involving as it does a metaphysical basis of dualism. There is, however, no objection to dualism or black magic when they are properly understood. See the account of the Master Therion's Great Magical Retirement by Lake Pasquaney, where He "crucified a toad in the Basilisk abode".

2. A wolf would be still better in the case of Mars. See 777 for the correspondences between various animals and the "32 Paths" of Nature.

3. There is also the question of its magical freedom. Sexual intercourse creates a link between its exponents, and therefore a responsibility.

4. It appears from the Magical Records of Frater Perdurabo that He made this particular sacrifice on an average about 150 times every year between 1912 e. v. and 1928 e. v. Contrast J. K. Huyman's "Läbas", where a perverted form of Magic of an analogous order is described. "It is the sacrifice of oneself spiritually. And the intelligence and innocence of that male child are the perfect understanding of the Magician, his one aim, without lust of result. And male he must be, because what

Every star must calculate its own orbit. All is will, and yet all is necessity. To swerve is ultimately impossible; to seek to swerve is to suffer.

The Beast 666 ordains by His authority that every man, every woman, and every intermediately sexed individual, shall be absolutely free to interpret and communicate self by means of any sexual practices whatsoever, whether direct or indirect, rational or symbolic, physiologically, legally, ethically, or religiously approved or no, provided only that all parties to any act are fully aware of all the implications and responsibilities thereof, and heartily agree thereto.

"When, where, and with whom ye will."

The phrase "with whom" has been practically covered by the comment "as ye will." One need no more than distinguish that the earlier phrase permits all manner of acts, the latter all possible partners. There would have been no furies for Oedipus, no disaster for Othello, Romeo, Pericles of Tyre, Laon and Cythna, if it were only agreed to let sleeping dogs lie, and mind one's own business. In real life, we have seen in our own times Oscar Wilde, Sir Charles Dilke, Parness, Canon Aitken and countless others, many of them engaged in first-rate work for the world, all wasted, because the mob must make believe to be "moral." This phrase abolishes the eleventh commandment, "Not to be found out," by authorizing incest, adultery, and pederasty, which every one now practices with humiliating precautions, which perpetuate the schoolboy's enjoyment of an escapade, and

make shame, slyness, cowardice and hypocrisy the conditions of success in life.

It is also the fact that the tendency of any individual to sexual irregularity is emphasized by the preoccupation with the subject which follows its factitious importance in modern society.

It is to be observed that politeness has forbidden any direct reference to the subject of sex to secure no happier result than to allow Sigmund Freud and others to prove that our every thought, speech, and gesture, conscious or unconscious, is an indirect reference!

Unless one wants to wreck the neighborhood, it is best to explode one's gunpowder in an unconfined space.

There are very few cases of "perverted hunger-instinct" in moderately healthy communities. War restrictions on food created dishonest devices to procure dainties, and artificial attempts to appease the ache of appetite by chemical counterfeits.

The south-sea islanders, pagan, amoral and naked, are temperate lovers, free from hysterical "crimes of passion," sex obsessions, and puritan persecution-mania; perversion is practically unknown, and monogamy is the general custom.

Even the civilized psychopaths of cities, forced into every kind of excess by the omnipresence or erotic suggestions and the contact of crazed crowds seething with suppressed sexuality, are not wholly past physical aid.

They are no sooner released from the persistent pressure by escaping to some place where the inhabitants treat the reproductive and the respiratory organs as equally innocent than they begin insensibly to forget their "fixed idea" forced on them by the foghorn of morality, so that their perversions perish, just as a coiled spring straightens itself when the external compulsion is removed. They revert to their natural sexual characters, which only in rare cases are other than

that of another star. It may, therefore, be considered improper, as a general rule, for your sexual gratification to destroy, deform, or displease any other star. Mutual consent to the act is the condition thereof. It must, of course, be understood that such consent is not always explicit. THE TUNNELS FOUND AT THE McMARTIN PRE-SCHOOL
A PRELIMINARY REPORT

A formal report will be released when forensic tests are concluded.

• **45 foot tunnel**

9 foot wide subterranean entrance found under west wall of the "Dog" room (Classroom 4, Ray Buckey's classroom).

- Avocado tree roots cut on both sides of the entrance.
- Disney bag, "Copyright 1982," found 4-1/2 feet below the classroom floor and 3" to 6" in from entrance and under foundation, Classroom 4.

Tunnel proceeded south, then east 45 feet through Classrooms 4 and 3, and north, then east 10 feet within Classroom 4.

- Tunnels were 30" wide, 44" to 46" deep, with top of the tunnel 30" under the classroom floor.
- The footing between Classrooms 3 and 4 was arched where the tunnel passed underneath and 12" shorter in depth at this location than same footing 12 feet to then north.

- Four large, upright containers were found in the tunnel under the arch, obviously hand placed.

A 9 foot wide chamber was found along the tunnel under Classroom 4. Top of chamber and top of sections of the tunnel had layers of plywood covered with tar paper which had apparently been supported by cinder blocks and 2" x 2" and 2" x 4" wooden posts found underneath.

Tunnel features made it evident that tunnel was hand dug.

• **7 foot tunnel extending into the triplex next door**

Tunnel extended from the bathrooms off the office and Classroom 1 to the front yard of the triplex next door. Front yard concealed from street by three-car garage.

Children described entrance and exiting tunnel in triplex yard exactly where tunnel and exit were found.

1 39" x 41" area under a hole cut in this neighbor's bathroom floor had been excavated and subsequently filled.

• **Other significant facts**

A small, white plastic plate with three pentagrams hand drawn on top of light green paint was found by the archaeologists in the stratified dirt in the play yard.

- Per historical archaeologist, pentagrams were hand drawn by an adult and not part of the manufacturer's design.

Many other artifacts found, whose analyses will be released upon completion of tests.

No doorknobs were on Classroom 3 door, only a dead bolt lock.

Each classroom had on and off light switch labeled "Fire Alarm." System did not connect to fire station but was used as an alert within the school.

More than 2000 artifacts were found under the school floor, including over 100 animal bones.

Due to severe time constraints our archaeology team was unable to further explore the extent of the tunnel networks. Above documented through photographs, notes, graphs, diagrams and charts. For more details call (213) 854-5172.

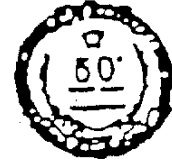

Dear Mr. Heller,

I am the former Senior Special Agent in charge of the FBI of the Los Angeles Division (retired) and the Independent American Party Candidate for U.S. Congress, District 1, Las Vegas, Nevada.

The Las Vegas Sun newspaper on September 10, 1996 (5A) in an article entitled "Errors at polls prompt request for new vote", Kathryn Ferguson, Registrar of Voters, stated "There were enough errors to have affected the outcome of the race". The internal audit reported 40 errors in 29 precincts of Assembly district one. At the September 17, 1996 County Commission meeting Ms. Ferguson reported that 13 voters voted in the wrong party i.e. Democrats voted Republican and vice versa, and in the wrong precincts. To avoid the risk of public scrutiny of a flawed recount in Assembly District 1, I believe Kathryn Ferguson quickly offered a re-election instead.

Because these machines are so susceptible to so many errors and misuse, I am very concerned about the Sequoia Pacific Voting machines and strongly oppose their use.

Regarding the Sequoia Voting machines, Howard J. Strauss a nationally recognized voting computer expert stated, "Voters may find themselves with a system that is unreliable, unpredictable and unauditible. This means you may find machines not working when you want to vote, you may find voting difficult and confusing, your vote may not go to the candidate you voted for and it may be impossible to figure out what went wrong -- or even if something went wrong." This is the same equipment that Clark County is using and Ms. Ferguson has confirmed that numerous voters voted in the wrong party, the wrong precinct and were denied their votes through errors.

I have information to prove the election was flawed in connection with the primary election held in Clark County, Nevada on September 3, 1996:

1. The Registrar of Clark County, Kathryn Ferguson ordered approximately twelve thousand absentee ballots opened prior to election day in violation of NRS. 293.333 which specifies that the absentee ballots are only to be opened "On the day of an election" and only "in the presence of a majority of the election board officers". This law was repeatedly violated starting five days prior to the Primary election. The Registrar of Voters of Washoe County was recently removed by the Secretary of State for a nearly identical violation, and this violation also warrants her removal for tampering with the ballots. The law was written to protect the integrity of the ballots, and Kathryn Ferguson has repeatedly compromised this security.

2. The Registrar of Clark County, Kathryn Ferguson, did not keep a separate count of absentee ballots of each candidate in violation of NRS 293.385,(4) which states "The absent ballots must be reported separately from the regular vote." This regulation was mandated in 1993 in SB. 250 to prevent absent ballot tampering by showing the exact vote count and percent of the absent ballots for each candidate.

3. The Clark County Commissioners did not put the Sequoia AVC purchase up for "open public bids" as required by the Government Purchasing Act NRS 332.045. Information has been received that a representative of Sequoia Pacific provided Clark County with the plan on how to circumvent the "open Bidding Laws" by tightly tailoring the request for only AVC characteristics to eliminate all known competition, and then claimed a "sole source exclusion."

4. The Sequoia Pacific Voting machines used in the Clark County elections, are illegal because they were never certified as required by Nevada Law. They are a model "D" using Ver. 5.0 firmware. The Sequoia certification papers signed by Cheryl Lau on November 11, 1993, were for a previous model 4.1 which was substantively different.

The official certification procedure of Nevada states:

"STEP THREE: . . . If the system is found to meet all statutory requirements, the Secretary of State will issue a Certificate of Approval. Such certificate shall be subject to the adoption of any further certification standards which may be approved by the Nevada Legislature, and shall be deemed invalid if substantive changes are subsequently made to the system." (italics mine)

NRS 293.105, (1) states that the voting system must first be:

- (a) Approved by the Secretary of State pursuant to subsection 2; or
- (b) Specifically authorized by law."

The Sequoia Pacific AVC model D, Ver. 5.0, has never been certified in Nevada and the current certification documents signed by former Secretary of State Cheryl Lau apply only to the previous model 4.1 and therefore the Clark County elections are illegal. Kathryn Ferguson has publicly stated at the September 9, 1996 Primary election certification meeting of the Commissioners that she will reconfigure the Sequoia to use 4 cartridge readers to speed up the ballot count, and intends to install new upgrade software prior to the November General election. Ms. Ferguson apparently does not intend to have the new software and the AVC's re-certified in accordance with Nevada Law and per NRS 293B.105.

At the July 12, 1996 Sequoia early voting test, it was announced that they were using a software program that processes the votes called "Teamwork" that I believe has never been certified for elections in Nevada. All software must be tested and certified by the State prior to use in an election. Clark County cannot indiscriminately use uncertified and untested hardware or software in Nevada's elections.

5. It is not possible to recount the votes using the Sequoia AVC machines because there are no physical records of the voters ballots created prior to casting their votes to document the voters original intent. You cannot pretend to do a recount when there are no original votes to recount.

The use of a voting system that does not use physical ballots that can be recounted, violates the Nevada Constitution Art. 1, sec. 2 which states "All elections by the people shall be by ballot." and to date the people of Nevada have not revised the Constitution to allow the use of electronic voting machines to replace their ballots. This provision is intended to protect the rights of the public to be able to watch the actual counting of the votes in public and as mandated in NRS 293.363.

6. Kathryn Ferguson has instituted a policy that prohibits citizens from observing the counting of the votes and ballots at the polling place and violation of NRS 293.305, 293.363, 293.385, 293.3602, 293.3606, 293B.330, 293B.335, 293B.353. The public has been repeatedly intimidated and threatened with arrest for peacefully trying to observe and film the counting of the votes, closing of the polls and observing the Canvass.


7. Kathryn Ferguson has repeatedly violated the Constitution regarding the freedom of the press by preventing members of the non-mainstream media from filming the election process as also provided for in NRS 293.274, (3). Under Color of Law, Ms. Ferguson with the assistance of deputy district attorney Mary Ann Miller, prohibited reporters with appropriate credentials from covering the election process, while allowing friendly press full access. On September 3, 1996 Mary Miller prevented a reporter from entering the poll at the Flamingo Library at 7:05 pm stating that she didn't have to state the law, she was following election department policy, which supersedes the law.

I brought the above violations to the attention of the Clark County Commissioners on September 17, 1996 and have information that other candidates wanted to speak before the Commissioners on these issues, but were intimidated by persons saying they would be subjected to financial ruin if they appeared and spoke out.

I am forwarding a copy of this letter to the Attorney General Del Pappa and the FBI because of the possibility of one or more local and Federal criminal election law violations.

I urge you to take immediate action as you did in Washoe County, to de-certify these Sequoia machines, and remove Clark County Registrar of Voters Kathryn Ferguson, from office for malfeasance and gross negligence. I request that you respond to these formal charges as soon as possible.

Cost of using the Sequoia Voting Machines.

1. The 1300 Sequoia AVC voting machines can only handle half of the voters of Clark County, approximately 200,000 of the 450,000 (45%) of registered voters on election day.
2. There will be long lines on election day, and the vote count will be late due to the inefficiency of the system, and the final vote count won't be in until morning.
3. The cost of Kathryn Ferguson's fiasco will be nine times or 900% greater than the optical scan system used in Reno which will have their election results in by 9:30 pm on election night.

Here's the math that Kathryn Ferguson forgot to do.

1. How many voters can the Sequoia AVC process on election day at a polling place?

Lets do the math

1 AVC machine can process approximately 15 voters per hour.
it takes an average of 4 minutes per voter divided into 60 min. = 15 voters per hr.
If 30 voters get in line to vote on 2 machines, it will take 1 hour.
Typical precincts have 500 voters, which will take (500 voters / 30 per hr) = 16.6 hrs.
There are only 12 hrs available on election day. Therefore, long lines and perhaps 50% of voters will be unable to vote.

2. On election day, the Sequoia AVC can only process approximately 200,000 voters, or approximately half of the voters of Clark County's, 450,000 registered voters.

The polls are open 12 hours. 12 hours X 15 voters/hr avg. = 180 voters per day
Total of 1125 AVC machines X 180 voters = 202,500 maximum capability.

80% voter turnout of 450,000 registered voters = 360,000 total voters
Less 25,000 early and absentee ballots = 335,000 election day voters
202,500 divide by 335,000 = 60% maximum turnout due to max capacity of AVC.

3. The cost per vote will be nearly 10 times more than other cities, such as Reno.

Compare Reno, (Washoe County) vs. Las Vegas, (Clark County)

Reno: estimated cost of election = \$352,000 + \$ 600,000 for optical scan system.
(Washoe Co.) Reno (Washoe Co.) has approximately 225,000 registered voters.
Estimated cost per voter = \$352,000/225,000 = \$1.54 per registered voter.
80% turn out = \$1.54/.8 = \$1.92 per voter

Las Vegas estimated cost of elections = \$4,000,000 + \$7,500,000 for Sequoia AVC.
(Clark Co.) Las Vegas (Clark Co.) has approximately 450,000 registered voters.
Estimated cost per voter = \$4,000,000/450,000 = \$8.88 per registered voter
50% turnout = 8.88/.5 = \$17.76 per vote.

Compare \$1.92 for Washoe Co. to \$17.76 for Clark County, This amounts to over 900% greater cost per vote than Washoe County.

To top this off, the Sequoia cannot process absentee ballots as the Optical scan, therefore Clark County will have to continue to use the old Votamatic punch card system at additional cost and additional manpower.

Obviously, County Manager, Pat Shalmy Registrar of Voters, Kathryn Ferguson "didn't do the math" for us taxpayers, lets do our math, for them . . . by firing them now.

I will not stop to discuss the moral aspect of this seizure except to say that there had been no declaration of war and that it was not clear why we should deliberately take this German property and appropriate it to the United States. The CHAIRMAN. Is there objection?

There was no objection.

Mr. CALLAWAY. Mr. Chairman, under unanimous consent, I insert in the Record at this point a statement showing the newspaper combination, which explains their activity in this war matter, just discussed by the gentleman from Pennsylvania [Mr. Moore]:

"In March, 1915, the J. P. Morgan interests, the steel, ship-building, and powder interests, and their subsidiary organizations, got together 12 men high up in the newspaper world and employed them to select the most influential newspapers in the United States and sufficient number of them to control generally the policy of the daily press of the United States.

"These 12 men worked the problem out by selecting 179 newspapers, and then began, by an elimination process, to retain only those necessary for the purpose of controlling the general policy of the daily press throughout the country. They found it was only necessary to purchase the control of 25 of the greatest papers. The 25 papers were agreed upon; emissaries were sent to purchase the policy, national and international, of these papers; an agreement was reached; the policy of the papers was bought, to be paid for by the month; an editor was furnished for each paper to properly supervise and edit information regarding the questions of preparedness, militarism, financial policies, and other things of national and international nature considered vital to the interests of the purchasers.

"This contract is in existence at the present time, and it accounts for the news columns of the daily press of the country

being filled with all sorts of preparedness arguments and misrepresentations as to the present condition of the United States Army and Navy, and the possibility and probability of the United States being attacked by foreign foes.

"This policy also included the suppression of everything in opposition to the wishes of the interests served. The effectiveness of this scheme has been conclusively demonstrated by the character of stuff carried in the daily press throughout the country since March, 1915. They have resorted to anything necessary to commercialize public sentiment and sandbag the National Congress into making extravagant and wasteful appropriations for the Army and Navy under the false pretense that it was necessary. Their stock argument is that it is 'patriotism.' They are playing on every prejudice and passion of the American people."

MR. MOORE of Pennsylvania. Mr. Chairman, I move to strike out the last word. I am in favor of this paragraph in the Navy appropriation bill, because I think the country ought to be fully prepared for any possible invasion; but I think the Congress ought to be careful about encouraging "rumors of war" when war has not actually been declared. Perhaps it would be safe to leave this matter to the President of the United States and to those who have direct knowledge upon the subject. I call attention, however, not only to these false reports of the *Housatonic* and about the *California*, but the steamship *Philadelphia* was reported sunk since the President was here, and yet the next day, after these reports had gone over the country like wildfire and everybody got excited about the *Philadelphia*, which naturally attracted interest in that great city and in the State of Pennsylvania, we found the *Philadelphia* had safely arrived in port, so that report was also in error. Now, whether by design or not I do not know, but it seems that most of these false reports come from London. There seems to be an intense desire there to tell us about German outrages and about American blood shed on foreign ships or to find that some American ship has been shot up. Mr. BARKLEY. Will the gentleman yield?

Mr. MOORE of Pennsylvania. I will yield to the gentleman.

Mr. BARKLEY. But was not there a statement in the morning paper that the colored man on that ship was a British subject?

Mr. MOORE of Pennsylvania. I am coming to that. The dispatches have made it appear that because of the loss of George Washington, an alleged American citizen, we are now in position to declare war against Germany. This morning's papers have headlines something like this: "Death of American on wrecked *Turino* reported to London. An American negro fireman, George Washington was killed, according to a report received to-day when the British steamship *Turino* was sunk by a German U boat in the war zone."

Now, that is enough to inflame every American—

Mr. FOSS. Will the gentleman yield?

Mr. MOORE of Pennsylvania. I will yield.

Mr. FOSS. I am very much interested in what the gentleman says, but how will the gentleman provide a remedy to stop these international thrills which we are receiving, which the publishers of these newspapers place in their headlines? Would he provide for a censorship of the press?

Mr. MOORE of Pennsylvania. Not at this time. I simply urge that the true facts and only the true facts be reported at this time when we are at the verge of an outbreak with a foreign country. [Applause.] I think it would be better for some of the editors to "shut up" when they do not know what they are talking about. [Applause.] I think it would be better for some of these professional patriots who have determined our international relations in advance, and who insist upon adjusting our diplomatic affairs in this crisis, to not only "shut up," but go tie a rope around their necks, attach an anchor to it, and jump into the sea. We could better afford to dispense with their meddling services than to plunge the people of this country into a foreign war. I think it would be far better for this country. [Applause.]

Mr. Chairman, I regret to say it, but we are gradually turning over the business of Congress, turning over all our constitutional rights, turning over our powers delegated by the people, to a lot of editors, theorists, and college professors who are not capable of conducting our affairs and to whom we should not abdicate.

Mr. GARDNER. Will the gentleman yield?

Mr. MOORE of Pennsylvania. I will yield to the gentleman from Massachusetts after I have disposed of George Washington. [Laughter.]

The CHAIRMAN. The time of the gentleman has expired. Mr. MOORE of Pennsylvania. All I can say then is that the papers report this afternoon that George Washington, the so-

called American, is a British subject; that is all. [Applause.]

Mr. Chairman, under leave to extend I wish to say that so many rumors and reports of an exaggerated character have appeared during the last few days that even the President, who certainly is as much concerned as any other citizen over the situation that confronts us, should take notice. We are dealing with a serious problem that invites the greatest deliberation. We ought not to be made the pawns of designing men in our own country or of any foreign power that would drag us into a war for selfish purposes. When our President has made up his mind that American honor is at stake and that we must enter upon a war to uphold it, I have no doubt he will find cordial support in the Congress of the United States, but the President has not yet indicated to Congress that the point has been reached where a declaration of war has become necessary. Until the President does come to this body with such information and facts as may warrant further action by Congress, it may not be well to aggravate the situation by giving too much credence to the untruthful rumors that have been bandied about with the evident purpose of finding some reason for provoking a declaration of war. At another time I shall extend in the Record, under permission granted to me, certain observations of Mr. Lincoln when he was a Member of the House, with respect to our Mexican complications in 1848. At present I shall content myself by quoting a single sentence from the speech made by Mr. Lincoln January 12 of that year, when he said:

When the war began it was my opinion that all those who, because of knowing too little, or because of knowing too much, could not conscientiously approve the conduct of the President (in the beginning of it) should, nevertheless, as good citizens and patriots remain silent on that point, at least until the war should be ended.

Mr. RAGSDALE. Mr. Chairman, I quite agree with the gentleman that there is too much noise and that the editors of this country may make too much noise. Fortunately the sound of their voices does not penetrate this Hall, while some of the noises which get in here might be suddenly ceased with a great deal of pleasure to some of us who have to stay here.

Mr. MOORE of Pennsylvania. Will the gentleman yield?

Mr. RAGSDALE. Certainly.

Mr. MOORE of Pennsylvania. The gentleman from Illinois said he, the gentleman from Illinois, had sense enough to keep still.

Mr. RAGSDALE. I know what he said, but he did not disclose the fact that he had politeness enough, while keeping still, to abide by the rules of the House in undertaking to chide me. That is for the gentleman's information, the gentleman from Pennsylvania.

Mr. MANN. I am abiding by the rules of the House.

Mr. RAGSDALE. Now, the gentleman from Pennsylvania is undertaking to lecture me.

Mr. MOORE of Pennsylvania. Oh, no! I have been lecturing the great editors and the political college professors. I did not have the gentleman in mind at all. [Applause.]

Mr. RAGSDALE. The gentleman's mind is rather limited in its memory.

Mr. MOORE of Pennsylvania. Surely my mind is not limited when I refer to the gentleman from South Carolina.

Mr. RAGSDALE. The gentleman says so little on the floor of this House that he ought to be given an opportunity in everybody's time to be recognized. May I yield further to the gentleman from Pennsylvania [Mr. Moore]?

Mr. MOORE of Pennsylvania. I merely wish to say that when I speak to the gentleman from South Carolina my mind is unlimited.

Mr. RAGSDALE. I am quite sure that is true. There are a great many things the gentleman possesses that are unlimited. His nerve is one of them. [Laughter.] The gentleman from Pennsylvania, Mr. Chairman, undertakes here to talk us about getting excited over the newspapers, and he undertakes to read from the newspapers, then proving that the conditions in Germany are not what they are reported to be in other newspapers. Now, why should we accept the statement from the newspapers selected by the gentleman any more than he would accept the statements made by other newspapers which he has not selected? I say to the gentleman that I quite agree with him that the people of our country ought not to be excited or hurried into war, but I say to the gentleman, sympathetic as I am with the people who want to preserve peace here, that if Germany has placed a restraining hand upon our ambassador, who went there in good faith to represent this Government as a Representative of my people I wish to exhaust every power within our command to bring him back here without regard to cost.

Mr. DYER. Will the gentleman yield?

Mr. RAGSDALE. Certainly.

French police have determined that Amschel Rothschild, heir to the fabulous Rothschild banking fortune, was murdered, according to well-placed European sources.

But, French Prime Minister Jacques Chirac has ordered police to close their investigation. Media outlets worldwide have ignored these mysterious developments. Some have reported the death was a suicide, other outlets disregarded the death altogether.

As if obeying an invisible choir-master, the world's competing news organizations silenced their strident sensationalism this month to cover up the mysterious death.

In the United States, newspapers controlled by Rupert Murdoch, the foreign-born owner of the world's largest media empire, either studiously ignored reports that Rothschild had met a violent end, or relegated it to the back pages as a mere "heart attack."

A SPOTLIGHT inquiry has established that Rothschild, 41, a billionaire investment banker and a noted sportsman in excellent health, was discovered lifeless on the floor of the bathroom of his suite at the luxu-

rious Bristol Hotel in Paris on July 8 at 7:32 pm.

Police found that he had been strangled with the heavy cord of his own bathrobe. One end of the cord was attached to a towel rack, as if to suggest that Rothschild's violent death was self-inflicted.

"The [French] crime scene investigators never called it 'suicide,'" reporter Thierry de Segonzac told The SPOTLIGHT in a telephone interview from Paris. "After photographing the body, one of the detectives gave the towel rack tied to the body a strong tug. It came right out of the wall."

Bank heir Rothschild hangs himself

PARIS — Amschel Rothschild, the man many believed would be the prestigious Rothschild Bank's next leader, hanged himself in a Paris luxury hotel, police said Thursday.

Rothschild's body was found by a cleaning lady Monday in his room at the Hotel Bristol, not far from the presidential Elysee Palace.

Rothschild, 41, was widely expected to take over the British merchant bank N.M. Rothschild and Sons.

Police officials, speaking on condition of anonymity, said the banker hanged himself. The bank refused to comment on the death.

Rothschild's wife Anita issued a statement Thursday saying the family was "completely shocked and devastated."

"Amschel's death was totally unexpected," Anita Rothschild said. "We shall not be saying anymore and would ask that everyone will respect the grief and deep sadness of our three young children and myself."

Rothschild was appointed chief executive of Rothschild Asset Management in 1990, later becoming its chairman. The moves led to speculation that he was being prepared to succeed his cousin Sir Evelyn Rothschild as chairman of the family bank.

The Rothschild family gained prominence by financing such projects as the construction of European railroads and the British military campaign that led to the final defeat of Napoleon at Waterloo in 1815.

Had Rothschild really attempted to hang himself from that rack, he would have ended up with nothing worse than a couple of holes in the wall, de Segonzac said.

There was no suicide note, no discernible cause or reason for a finding of suicide, knowledgeable sources say. Rothschild, an athletic and imperious figure in early middle age, was a renowned race car driver and the husband of Anita Guinness, herself one of the world's wealthiest heiresses. The couple had three children who spent most of their time on the family's baronial estate in Suffolk, England.

Rothschild had arrived in Paris to take over one of the many family consortium's French assets—management operations which were to be merged with N.M Rothschild's London-based investment banking center.

"Far from being 'troubled,' Amschel Rothschild's star was on the rise and he relished his success," says an executive at Keefe, Bruyetter and Co, a respected Wall Street monitor of the

financial-services industry. "I don't believe for a moment he suddenly went and killed himself. There's much more to this story."

But with frantic speed—within an hour after the body's discovery—authorities and news executives in both France and Britain launched an unusual joint offensive to preempt a public inquiry or a press investigation into the circumstances of Rothschild's death. **RUPERT**

"Murdoch sent a hotline fax to his 600-odd editors and news managers

around the world, ordering them to report Amschel's death as a heart attack, if at all," said British broadcast reporter Ian Gooding. "No one around here has ever seen such pressure to kill a front-page story. But in the end, the cover-up was complete."●

Antigovernment groups to rally in Washington over rights

WASHINGTON — Several antigovernment groups, including private militias, are holding a rally in Washington this weekend to draw attention to what they say is an erosion of Americans' constitutional rights.

It will be the first high-profile rally in the capital by antigovernment groups since last year's Oklahoma City bombing.

"We want to make people aware of the dangers that the Constitution and the Bill of Rights are in, and

how it's getting worse," said Joseph Corey, director of the Committee on 1776, which focuses on opposing gun control.

Organizers of the "Rally for the Bill of Rights," scheduled for tomorrow and Sunday, hope to attract 15,000 people. The gathering will feature speakers who have written anti-Semitic literature, and others who push theories of a governmental conspiracy to undermine Americans' rights.

The group held a similar rally in June 1995, just three months after

the Oklahoma City tragedy. By then, bombing suspect Timothy McVeigh's sympathy militia groups had been well-documented, something Corey thinks helped keep attendance down to 7,000.

"That frightened a lot of people," Corey said. "I think a lot of wives told their husbands, 'You're not going ...'"

A news release mailed by organizers to media outlets about this year's rally states that its organizers oppose high taxes, "bureaucratic overregulation" and gun control. It

also warns of computerized highway detection systems designed to "transmit your driving habits back to the state."

Some panelists — including former FBI agent Ted Gunderson — are active proponents of these various government conspiracy theories. Others, such as Larry Pratt, head of Gun Owners of America, will speak out against gun control.

Other speakers include Eustace Mullins, an author of books on supposed Jewish plots.

"He has published a great deal of

anti-Semitic conspiracy material," said Angie Lowery of the Southern Poverty Law Center, a group that monitors racist and hate groups. "His writings proclaim that Jews are behind a worldwide conspiracy to take over this country, to run the U.N., and to control the world's financial markets."

Corey, for his part, insisted that his group is not a militia organization, and that those groups represent "a very small minority" of the groups he expected to attend.

He also noted that two of the mili-

tia groups planning to show up — the Georgia Defense League and a New England-based militia — are headed by blacks.

"You cannot defend the Bill of Rights and the Constitution and be racist or anti-Semitic," he said. "It just doesn't work that way."

The other main sponsor of the event is Citizens Against Legal Loopholes, a San Diego group formed in 1993 to protest federal bankruptcy law and that now operates a mail-order business marketing conservative videos and books.

Interview With The Grand Juror Who Wouldn't Shut Up: The Oklahoma City Bombing Case - Part Two

In the aftermath of the Oklahoma City bombing tragedy on April 19, 1995, independent researchers have begun to lift the lid on very troubling details of the crime. As in the JFK assassination, disturbing evidence of a different sort of murder scenario from the official version has emerged; and typically it has been relegated to the "conspiracy file" by the mainstream press. Very serious questions about bombs other than the ammonium nitrate truck bomb have surfaced. McVeigh himself in some eyes begins to appear as the dupe, the patsy left holding the bag. Key stories about federal law enforcement agencies having advance warning of a bombing in Oklahoma City are gaining credibility. Researchers on the scene in Oklahoma City are talking about the FBI intimidating witnesses and thereby shaping a false version of events. The Grand Jury itself which has brought indictments against Tim McVeigh and Terry Nichols has come under fire for ignoring other potential suspects.

Are we being treated to what is basically a gigantic government press release, a foreshortening and distorting of the case?

On December 14, 1995, I interviewed Hoppy Heidelberg, a grand juror in the Oklahoma City case. Several months earlier Heidelberg had, off the record, engaged in a conversation with Lawrence Myers of *Media Bypass* magazine. Subsequently thrown off the Grand Jury by Judge David Russell for allegedly going public in the subsequent *Media Bypass* article, Heidelberg is very critical of the government's refusal to pursue murder suspects beyond Tim McVeigh and Terry Nichols. Which suspects? Start especially with the notorious John Doe 2

Grand jurors are not permitted to reveal details of legal proceedings on pain of contempt-of-court citation and imprisonment. Heidelberg has now risked being accused of this, because he feels his Grand Jury was steered away from evidence that could implicate the government itself in the bombing.

Has such a straightforward rebellion by a grand juror ever taken place before in a high profile American trial? After the *Media Bypass* article appeared, the major media gave the Heidelberg story one or two days and passed on to more routine matters: car accidents, murders, storms and potential medical breakthroughs

Meanwhile Heidelberg has wrestled with his discovery that grand juries are basically run by the prosecuting attorneys who herd jurors like sheep in bringing indictments. (Indictment being the end product of a grand jury, the defendant is then bound over for trial.)

However, with a little research Heidelberg has also discovered that grand juries are potentially vital bodies in which jurors are legally permitted to actually bypass prosecutors and question witnesses directly, find and call witnesses and in general investigate the crime at hand.

Such a citizen-body, if honored -- not sidetracked and intimidated by prosecutors and judges -- would, of course, add a whole new dimension to the American legal scene. In practice though, these grand juries

this guy as a CIA type operator. I found out later he was CIA although he had lots of impressive credentials. His testimony was very effective, but the whole thing was bogus. A dog and pony show. Now this is hypothetical. If you want to convince someone that ANFO [ammonium nitrate plus fuel oil] is powerful, show a film of a truck and blow the hell out of it and then say you used only five pounds of ANFO to do it. But how could the grand jurors be sure that it was only five pounds? All the demonstrations the prosecution used were like that. Obviously to dupe an unsophisticated audience [the Grand Jury]. But it's easy to see through this.

How did you feel when you first got on to the Grand Jury?

I didn't go in trying to cause trouble. I tried to get along. I wasn't wanting to be kicked off the Grand Jury. I wanted to hang in there longer. As it turns out I wouldn't have heard more about Oklahoma City, anyway. They were done with that.

You've had attention from the mainstream press. You were on Good Morning America and The Today Show.

Everybody's interviewed me. But they want me to turn out to be a nut. When I don't come off that way, they don't print the interview, they don't do the story.

Who doesn't do the story, for example?

The New York Times. I've had contacts with them. And with Time, Newsweek, CBS. They don't want to give me any stature. I was supposed to do 20/20, Dateline, a whole bunch of them. But after my appearance on Good Morning America and The Today Show, they ignored me. Even my own governor in Oklahoma [Frank Keating] was calling me a nut for a while. Then that didn't work because people know me. So he invited me to his mansion; but I didn't go.

There are so many uninterviewed people in this story.

It would seem to me that those rescue workers who found unexploded bombs in the federal building there's got to be somebody who knows that -- it wasn't a hoax. They found two more bombs that didn't explode in there. Somebody somewhere can verify this. "Yeah, we found those bombs and reported it and gave them to whoever."

Unless they have been told to shut up about it. Unless this is more manipulation of evidence.

Yeah. Even with the Grand Jury witnesses, you could see they didn't remember everything they remembered. Their memories had deteriorated. (laughs) The FBI does this to people. "Your remembering would be counter-productive to the investigation. It's your patriotic duty to forget." I got to hear tape interviews with secret witnesses occasionally [witnesses already influenced by the FBI]. It takes a tremendous amount to get them to tell what they really know because they think that they'll screw up the government's investigation. But when some real witnesses the media found who had ID'ed McVeigh at the bombing scene didn't show up at the Grand Jury... How do you explain their absence? It was a dog and pony show. The prosecution spent a lot of money bringing in witnesses who knew nothing about the bombing. How many witnesses do you need to bring in to say that McVeigh was at gun shows. Not ten witnesses! That's irrelevant! Many people go to gun shows and don't blow up buildings. They [the prosecution] had this Grand Jury to the point where jurors were asking "How can gun shows be legal in the U.S.?" These witnesses were used to get across the idea that McVeigh, because he went to gun shows, was a bad guy. But we heard nothing from real witnesses who saw McVeigh at the crime scene.
